3.A Updates to TPA Funding Programs Guidelines and Scoring Systems

JASON PRICE, TPA Transportation Improvement Plan (TIP) Coordinator, provided an overview of the Local Initiatives (LI), Transportation Alternatives (TA), and State Road Modifications (SRM) funding programs. These programs provide an annual, competitive application process to prioritize federal funds towards community identified projects that accomplish TPA goals and objectives.

VIJAY MISHRA inquired about eligibility for carbon reduction projects within TPA funding programs.

3.B South Florida Regional Transportation Authority (SFRTA) Update

LORAINE CARGILL, AICP, SFRTA Director of Strategic Planning, and GREG GABRIEL, TPA Transit Coordinator, provided an update about the Northern Layover Facility and Tri-Tail Coastal Link.

There were no public comments on this item.

Member discussion ensued about consultant work orders, project ownership on the Northern Layover Facility, and overall project costs.

3.C Florida Department of Transportation (FDOT) Update

JENNIFER CARVER, Statewide Community Planning Coordinator FDOT District 4, provided a presentation about FDOT's Resiliency Action Plan.

LOIS BUSH, Policy Planning Section Leader FDOT District 4, noted that resiliency planning often occurs during emergency repair.

JAMES POOLE, District Drainage Engineer FDOT District 4, described data utilized to predict flooding.
