ALEX HANSEN noted that there were too many acronyms used in the backup materials and suggested staff add the definitions in future agenda items.

XAVIER FALCONI noted a difference between information listed in agenda item 3.A and information listed in agenda item 2.B for the same West Palm Beach trolley and trolley shelter projects.

Member discussion ensued about significant project cost increases, in part, due to inflation and the impact it will have on municipalities.

Vicki Gatanis joined the meeting virtually.

2.C. <u>MOTION TO RECOMMEND ENDORSEMENT:</u> of the FDOT FY 2024 2028 Draft Tentative Work Program (DTWP)

JASON PRICE, ANDREW UHLIR, FDOT Staff, and Turnpike Staff were invited to present this item.

KEITH KRIEGER, general public, commented on the location of engineering firms contracted through FDOT for projects in Palm Beach County.

KIM DELANEY inquired about the increased utilization of the Turnpike and requested specific Palm Beach County Turnpike travel data.

ALEX HANSEN asked about increasing the number of electric vehicle charging stations at service plazas.

NARESH MACHAVARAPU expressed that he did not support funding for SW 18th Street being allocated to State Road (SR) 7.

JOHN KRANE noted that the Local Initiative (LI) projects were not programmed in the DTWP, which is not the same as a reallocation of funds.

NATALIE CROWLEY sought clarification on proposed shifts in funding.

TERRENCE BAILEY asked about using LI ranking from this application round for next year's project ranking.

JAMIE BROWN asked if priority could be given to previously submitted projects.

Member Discussion ensued about funds being allocated to SR 7 instead of being allocated to LI projects 22-1 through 22-7.

KURSHID MOHYUDDIN, PBC Planning, made a public comment on funding moving away from LI projects.

MOTION to Recommend Endorsement of FY 24 – 28 DTWP with LI Projects 22-1 through 22-7 to be funded in the DTWP made by Natalie Crowley and seconded by Terrence Bailey and carried 23-2 with dissention due to SR-7 inclusion as depicted in the table below.
