NATIONAL STATS

Florida ranks #3 in the nation in trespassing casualties and #6 in highway-rail grade crossing collisions.



SOUTH FLORIDA RAIL CORRIDOR




- The 73.4-mile stretch of rail spans 18 stations over a dozen municipalities with 72 rail crossings on corridor.
- Right of way vehicle incursions and vehicles stopped on tracks continue to be the biggest issue with grade crossings.
- Combination of issues include confusing roadway markings and directional arrows, proximity of I-95 exit ramps, amount of tourists unfamiliar with roads, GPS confusion and careless drivers.
- Most trespassing caused by people seeking shortcuts either across or alongside tracks.
- Persons seeking to commit suicide by train generally enter at a crossing and linger in a secluded area.




INCIDENT REPORTS

- Trespassing violations and related "near misses" go undetected due to our inability to observe happenings in and around the railway and our current, limited capacity to provide comprehensive enforcement.
- Installation of cut resistant, nonscalable fencing installed in select areas of Palm Beach County resulted in reduction of trespassing and no trespasser strikes in area in 2021.
- Plastic delineators decreased vehicle incursions by 95% where installed.

ENGINEERING PROJECTS

- SFRTA and FDOT are making the installation of delineators a road crossing standard.
- FDOT/SFRTA have identified (10) road crossings that have a history of vehicle intrusions that will have delineators installed.
- The new FDOT "No Trespassing" signs with FS statue will be posted on all railroad crossing rehab projects at all (4) quadrants.
- Approximately .5 miles of "premium" fencing with wayside signage will be installed in WPB in a high trespassing intrusion area near an elementary school.



ENGINEERING PROJECTS

- Approximately 3 miles of No Trespassing signage will be installed in WPB.
- SFRTA and FDOT are focusing on ROW dumping and vegetation mediation.
- SFRTA/FDOT are engaged in a road crossing signal safety project(s) that includes LED lights and crossing warning protection upgrades affecting (21) road crossings.
- SFRTA/FDOT will be conducting a new "wireless" crossing warning activation technology in a "shadow mode" trial operation to prevent pre-activations of crossings that are near to a commuter station stop.



PARTNERING EFFORTS



- FDOT awarded SFRTA a 2-Year \$200,000 grant for railroad safety, including trespassing prevention measures covering FY 2021 and 2022
- Safety videos uploaded on Tri-Rail's YouTube page where they can be easily shared on social media

THE WORK CONTINUES

- SFRTA awarded \$56,500 FRA grant to implement Railroad Trespassing Suicide Prevention Program, thanks in great part to partnership with 2-1-1
- Advent of social media allows for digital media to be shared continuously to boost safety message
