### 2.B. MOTION TO RECOMMEND ADOPTION of Targets for Federal Performance Measures

ANDREW UHLIR, TPA Deputy Director of Programs, was invited to present this item.

There were no public comments on this item.

Member discussion ensued about the practicality of setting a goal of zero fatalities, implementation of performance measures, and methodology for calculating performance measures. Members noted seeing more violent crashes on the roadways, increasing numbers of drivers, and noted the goal in planning is to avoid adding any additional deaths, which is why the goal is zero fatalities.

VALERIE NEILSON, TPA Executive Director, noted that Vision Zero is a vison with grant funds being allocated to projects that prioritize said vision.

Ryan Rossi left the meeting.
