CHRISTIAN SANTA-GONAZALEZ stated his concern about community opposition potentially leading to project delays or cancellations.

DAVID WILOCH asked if staff believes more municipalities will apply for the program this year.

CHAIR THOBURN reminded the committee members to attend the scoring meeting VZAC members have every year to score projects.
