






Red Lining




Proposed Park & Ride

- Voter-approved investment in transit system from 2020
- Initial Investment includes 98 station areas
- 2 light rail lines, 2 commuter rail lines, multiple new rapid bus lines, and park and rides
- Designed to improve access to essential jobs, health care and education - making our communities more livable, equitable and sustainable


Displacement Risk

\$300 Million Anti-Displacement Funding | Contract with Voters

- When voters approved Project Connect in November 2020, Proposition A included \$300 million for antidisplacement work.
- Project Connect Anti-Displacement funding will help prevent the displacement of people due to rising costs that may result from transitoriented development.
- Anti-displacement initiatives will create long-term impact with focus on creating affordable housing units and asset-building opportunities that enhance people's economic mobility and prevent displacement.
- This funding will help affordable areas remain affordable to the people who want to stay.




BE IT FURTHER RESOLVED:

The City Manager is directed to include in the Joint Powers Agreement with Austin Transit Partnership and Capital Metro, a provision to provide a total of \$300,000,000 of the Project Connect Tax Revenue, in accordance with the Implementation Sequence Plan as shown in Exhibit A, to Austin Transit Partnership for the purpose of (1) acquiring real property, and (2) financing tools and other anti-displacement strategies related to the implementation of Project Connect. The following two Be It Resolved clauses provide direction for the expenditure of these funds.



Community Initiated Solutions - \$20 Million

- Competitive process
- Community-initiated, neighborhood-focused programs and projects
- Focus on protecting people who are most vulnerable
- Investment types:
 - Renter/tenant stabilization
 - Expanding and preserving home ownership opportunities
 - Other housing-focused anti-displacement strategies that build economic mobility







Where Does Planning Fit In?

Ideal:

- Land use planning well in advance of transit system construction
- Plan for places that support transit AND provide a range of benefits to a range of people

Real World:


- Patchwork of plans and regulations (some transit-supportive, some not)
- Land use decision-making contentious
- Rich tradition of property specific land use decisions
- Failure of comprehensive Land Development Code rewrite
- Implementation of Project Connect transit system is imminent
- Urgency around anti-displacement/affordability, investments can't wait for planning



How Does the ETOD Policy **Plan Relate to Project Connect?**


- The ETOD Policy Plan provides a comprehensive policy framework to guide future development around the Project Connect system.

What's in the ETOD Policy Plan?



Austin City Council Accepts the ETOD Policy Plan

On March 9, 2023 Council accepted the ETOD Policy Plan as a resolution with amendments and directed city staff to:

- Incorporate ETOD policy tools for station areas designated in the upcoming Northeast Austin District planning process
- Initiate amendments to the Imagine Austin Comprehensive Plan
- Initiate amendments to the City's Land Development Code
 - Begin the work to develop an ETOD Overlay

Present an implementation plan that will include:

- Policy tools prioritized for implementation
- Targeted outcomes for tool implementation
- Timeline for tool implementation
- Identification of funding sources and other resources for tool implementation; and
- Performance measures to assess tool implementation success

*Update to be provided by May 26, 2023 and full implementation plan by September 12, 2023

- Policy Tools that apply systemwide


Geographically Specific Approach
