# When is a TIP Amendment Needed?

- Add or delete a project
- Cost increases more than 20% and \$2 million
- Changes to scope of work
  - Length change by 1/2 mile and 20%
  - Number of through traffic lanes
- Change to project phase initiation date

**Only impacts projects in the Amendment**

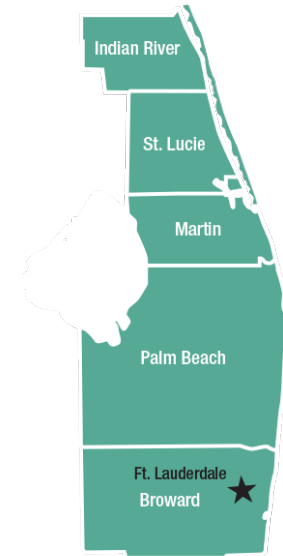
