One life lost on our roadways is one too many. To work towards solving this, FDOT started the Target Zero initiative.



Until we reach the number ZERO, the Department will continue exhaustive efforts to do all that we can to help move the needle.













Project completed! We're happy to announce that the upgrades at Lake Worth Road & Haverhill Road in City of Greenacres, Florida -Government are now finished!

This project has improved safety and accessibility by milling and resurfacing the roadway, modifying the median for better driver safety, and replacing the traffic signal mast arm. New curb & gutter, sidewalks, and bus stop pads have been installed, along with upgraded pavement markings, signs, and signals. We've also met ADA standards with new pedestrian signals and curb ramps.







## **General Work Program**

- FDOT updates construction and right of way costs on an annual basis
- Overall, project costs increased with respect to last year
- Some funding allocations were lower than prior cycle. The estimated revenue distribution is based on percent population of the state

- Goal is to maintain projects that were committed in the common four years related to safety, preservation and maintenance
- New phases are generally programmed in the "new" 5th year
- District 4 Work Program is balanced to the allocations received





The project widens a segment of Turnpike Mainline / SR 91 from north of Glades Road / SR 808 to north of the L-38 Canal. The widening will increase the number of travel lanes from six to ten. The project also includes replacement of the Yamato Road bridges (MP 77.7), widening the bridge over Clint Moore Road (MP 78.7), replacement of the bridge over L-38 Canal (MP 79.7), milling and resurfacing, noise barriers, roadway lighting, and signing and pavement markings.
