### 2. ACTION ITEMS

- A. MOTION TO RECOMMEND ADOPTION of Amendment #3 to the TPA's 2045 Long Range Transportation Plan (LRTP)

The 2045 LRTP includes regionally significant transportation projects from Palm Beach County's Road Program and local Capital Improvement Programs. The TIP is the TPA's five-year funding program for transportation projects in Palm Beach County. FDOT requests approval of the attached FY 2024-2028 TIP amendment:

US 1 from 59<sup>th</sup> St to Northlake Blvd (#4383862): project cost increase of \$2,241,523 due to additional bridge repair work.
