3. INFORMATION ITEMS

3.B. Draft Fiscal Year (FY)2025-2029 Transportation Improvement Program (TIP)

ANDREW UHLIR, Deputy Director of Programs, presented this item before item 3.A. The full presentation can be viewed at PalmBeachTPA.org/TAC.

Joyce Cai joined the meeting at 9:27am.

BRYAN DAVIS inquired about the connection between Beach Club Way and SUN Trail. He also questioned whether there is federal funding available for this project.

JIM BELL clarified that the project is located along A1A rather than Beach Club Way.

ALEX HANSEN requested that staff highlight proposed changes to existing values in the TIP document for transparency.

CHAIR CROWLEY questioned the implementation of the Northlake Interchange and I-95 project. She asked if any proposed revisions have been completed.

3.A. Turnpike Crossover in Martin County

JAZLYN HEYWOOD and BILL HOWELL, FDOT Representatives, presented this item after 3.B. The full presentation can be viewed at PalmBeachTPA.org/TAC.

There were no public comments on this item.

ALEX HANSEN inquired on the feedback received from Martin County Metropolitan Planning Organization (MPO) regarding the project.

JIM BELL asked if FDOT staff met with the Town of Hobe Sound.

THOMAS HERNANDEZ noted the Town of Jupiter is tracking the project. He echoed the crossover will reduce crossover traffic in Jupiter significantly.

KIM DELANEY expressed the importance of the project for connectivity.

QUAN YAN questioned whether the traffic would transfer to I-95 or Turnpike once the project is completed.

3.C. LRTP Funding Overview

KHURSHID MOHYUDDIN, stated a public comment, noting the comp plan must include near-term and long-range funding periods.

DENISE MALONE requested confirmation that the City of Greenacres's project was received by the TPA.

ALEX HANSEN identified a project within the City of West Palm Beach boundaries which was submitted by Palm Beach County. He questioned the process of submittal, because the City of West Palm Beach was not aware of the project.

CHAIR CROWLEY stated she found the map and proposals to be helpful. She mentioned the transportation surtax and expressed support for Palm Beach County being in favorable position to receive the surtax.
