MOTION TO RECOMMEND ADOPTION Fiscal Year (FY) 2025-2026 Unified Planning Α. Work Program (UPWP)

TPA staff will present the attached FY 2025-2026 UPWP, the 2-year business plan and budget for the agency covering a period of July 1, 2024 to June 30, 2026. The UPWP serves as the TPA's application for federal planning funds and includes a description of the planning work, deliverables, timeframes, source and amount of funding requested.

A. Draft Fiscal Year (FY) 2025 – 2029 Transportation Improvement Program (TIP)

The TIP is the five-year funding program for transportation projects in Palm Beach County. This program was developed in collaboration with the Florida Department of Transportation (FDOT) and various local agencies and includes transportation projects funded by federal, state, and local sources for all modes of transportation. The TIP reflects revenue expectations for the next five fiscal years and programs projects by phase, year, and funding source.

This is the first review of the TIP. The final recommendation for adoption will occur June 7, 2024 with final adoption by the TPA Governing Board on June 20, 2024.
