2. ACTION ITEMS

A. <u>MOTION TO RECOMMEND ADOPTION</u> of Amendment #4 to the TPA's Transportation Improvement Program (TIP)

The TIP is the TPA's five-year funding program for transportation projects in Palm Beach County. TPA staff will present on the following attached FDOT amendment requests for the Fiscal Year (FY) 2024-2028 TIP:

SR-807/Congress Avenue at 10th North (4493471) – add a new right-of-way phase of \$590,793.

B. MOTION TO RECOMMEND ADOPTION of FY 2025-2029 TIP

The TIP is the five-year funding program for transportation projects in Palm Beach County. The TIP includes transportation projects funded by federal, state, and local

sources for all modes of transportation. The TIP also reflects revenue expectations for the next five fiscal years and programmed projects by phase, year, and funding source.
