SUBJECT: Second Amendment to Executive Director's Employment Agreement

DATE: July 8, 2024

The TPA Executive Committee and the Executive Director are involved in discussions regarding the Executive Director's contract. That contract expires next July. Additionally, the contract terms need to be reviewed and updated. Consequently, the Executive Committee is looking at a two-step process which will lead to a revised agreement.

The attached Second Amendment to the Employment Agreement is intended to become effective simultaneous with the beginning of the TPA's new fiscal year on July 1, 2024. Some additional revisions, which the Executive Committee is reviewing, will be presented this fall in the form of a Restated Employment Agreement.

The attached Second Amendment includes two changes to the current agreement. With regard to deferred compensation, the deferred compensation paid is currently \$13,750 per year. The proposed amendment will change this amount to an amount paid yearly which is equal to 10% of the Executive Director's salary effective as of July 1, 2024. This amount provides for a deferred compensation amount that accounts for inflation and is more consistent with the type of payment made to the Executive Directors of other MPOs.

The Second Amendment also provides an amendment to pay \$450 per month as a "local travel allowance" for travel expenses within a 100-mile radius of the TPA. Currently, the Executive Director can submit for reimbursement for mileage and related travel expenses. This process involves significant paperwork and record-keeping for both the TPA Director and staff. A simple process would be to pay a monthly amount and more carefully describe what types of expenses it is intended to provide reimbursement for. This is also more consistent with how other MPO Executive Directors handle local transportation expenses.

The new \$450 per month "local travel allowance" is intended to cover reimbursement for use of a car, mileage, rental car, Uber/Lyft, taxi or similar transportation services, parking and transit tickets, including travel on Brightline and Tri-Rail, and toll road expenses incurred while traveling within 100 miles of the TPA office. Said reimbursement is not intended to cover costs of travel to a location of more than 100 miles (one way) from the TPA office, or for travel to a meeting or conference involving overnight travel. Those types of expenses will continue to be payable on a reimbursable basis.

SECOND AMENDMENT TO EMPLOYMENT AGREEMENT - EXECUTIVE DIRECTOR

THIS SECOND AMENDMENT TO EMPLOYMENT AGREEMENT - EXECUTIVE DIRECTOR is entered into this ____ day of July, 2024, by and between the Palm Beach MPO, d/b/a the Palm Beach Transportation Planning Agency (herein: the "TPA"), an agency created pursuant to federal and state law, through its Governing Board ((herein: the "Governing Board") whose address is 301 Datura Street, West Palm Beach, Florida, 33401, and Valerie Neilson (herein: the "Director").

WITNESSETH:

WHEREAS, the TPA entered into an employment agreement with the Executive Director to fulfill the duties of the Palm Beach TPA Executive Director position on July 21, 2022 (the "Employment Agreement"); and

WHEREAS, the Employment Agreement was amended by that certain First Amendment To Employment Agreement – Executive Director; and

WHEREAS, the TPA and Executive Director desire to amend the aforementioned Employment Agreement,

NOW, THEREFORE, in consideration of the mutual covenants and promises set forth herein, the parties agree as follows:

- 1. Recitals. Each and all of the foregoing recitals be and the same are hereby incorporated in this Agreement.
- 2. Section 3. Salary and Benefits, of the Employment Agreement is amended as follows:

3. SALARY AND BENEFITS.

* *

c. Deferred Income. In addition to the base salary, the Director shall earn an annual amount of \$20,841,00 \$13,750.00 annually in deferred income while employed under this Agreement. The deferred income contribution shall be made in prorated payments during each pay period to a Deferred Income Account chosen jointly by the Director and the TPA. All contributions to and interest earned by this account are governed by and subject to federal and state statutes. The Director's right to such account shall not be affected by the termination of employment with the TPA for any reason whatsoever. The Director shall also accrue

benefits pursuant to the Florida Retirement System as a TPA employee.

* * *

3. Section 8 b. Automobile and Equipment, of the Employment Agreement is amended as follows:

8. AUTOMOBILE AND EQUIPMENT.

* * *

- The DIRECTOR shall receive \$450 no automobile reimbursement payable monthly for local travel within 100 miles of the TPA office. . but the The DIRECTOR is also eligible to receive travel reimbursement for TPA-related business travel subject to applicable Federal, State of Florida, and TPA policy requirements for travel of over 100 miles distance (one way) from the TPA office, or for travel which involves overnight travel for a conference or meeting; and all provided that funds have been budgeted in the TPA's annual budget document. With regard to the local travel allowance for travel within 100 miles (one way) of the TPA office or nonovernight travel, said monthly reimbursement is intended to cover reimbursement for car allowance, mileage, rental car, use of Uber/Lyft, taxi or similar transportation services, parking and transit tickets, including travel on Brightline and Tri-Rail, and toll road expenses incurred while traveling within 100 miles of the TPA office.
- 4. Interpretation. In interpreting this amendment to the Employment Agreement, <u>underlined</u> words indicate additions to existing text, and stricken through words include deletions from existing text.
- 5. Effective Date. This Agreement shall become effective retroactive to July 1, 2024 after approval by the TPA Governing Board and execution of this Second Amendment by both parties.

Background/History

Section 2 (Employment Policies) of the TPA's Personnel Rules and Regulations (referred to as the "Personnel Handbook") is under the purview of the Board.

Proposed Action/Summary of Proposed Changes

The enclosed Resolution, which amends Section 2 of the Personnel Handbook, has been prepared by the TPA's General Counsel and reviewed by the Executive Director. As such, the attached Resolution, inclusive of the amended provisions of Section 2 of the Personnel Handbook, has been prepared for presentation to the Board for review and approval.

The substantive changes are summarized below:

- Retirement Plan Presently, employees may participate in the TPA's 401(a) plan. The proposed change allows employees to participate in "retirement savings plans and programs"; thereby allowing the TPA to offer other types of retirement plans.
- <u>Tuition Reimbursement</u> Presently, employees who leave TPA employment within one year after receiving tuition reimbursement must repay a pro-rated amount of the total tuition costs. The proposed change requires the departing employee to pay the entire tuition cost.
- <u>Sick Leave Payout</u> Presently, employees are paid ten (10) percent of sick leave upon termination, without exception. The proposed change conditions payout on leaving employment in "good standing."
- <u>Paid Parental Leave</u> Presently, employees are eligible for six (6) weeks of paid parental leave, with the ability to extend for two (2) additional weeks. The proposed change removes the two (2) week extension; instead, requiring employees to use accrued leave.

TPA RESOLUTION 2024-

RESOLUTION OF THE PALM **BEACH TRANSPORTATION PLANNING AGENCY** (TPA) **AMENDING PERSONNEL RULES** THE AND REGULATIONS (PERSONNEL HANDBOOK); PROVIDING FOR CONFLICTS, SEVERABILITY; PROVIDING FOR AN **EFFECTIVE DATE.**

WHEREAS, the Palm Beach MPO, doing business as the Palm Beach Transportation Planning Agency (TPA), a public agency created in accordance with and operating pursuant to 23 U.S.C. 134, 49 U.S.C. 5303, and Sections 163.01 and 339.175, Florida Statutes, is the designated and duly constituted body responsible for the urban transportation planning process for Palm Beach County; and

WHEREAS, the TPA has adopted personnel rules and regulations via Resolution No. 17, which is commonly referred to as the Personnel Handbook, in order to ensure that employees and prospective employees are treated in a manner consistent with applicable employment laws and regulations; and

WHEREAS, the Personnel Handbook addresses employee benefits, including the provision of retirement savings, tuition reimbursement, sick leave and paid parental leave; and

WHEREAS, amending the Personnel Handbook is being proposed by staff to permit additional options for retirement saving, claw back tuition reimbursement for departing employees, condition sick leave payout upon leaving in good standing and disallow extending paid parent leave; and

WHEREAS, TPA staff recommends approving an amendment of the Personnel Handbook; and WHEREAS, the TPA Governing Board finds the adoption of this amendment to be in furtherance of the public interest.

NOW THEREFORE, BE IT RESOLVED BY THE PALM BEACH MPO, d/b/a PALM BEACH TRANSPORTATION PLANNING AGENCY, THAT1:

SECTION 1. The foregoing recitals are hereby adopted and declared to be true and correct and are incorporated herein.

SECTION 2. That Section 2.3.B.3, Retirement Savings, of the Personnel Handbook be amended as follows:

B. Retirement Savings

3. The TPA may provide all employees the opportunity to participate in retirement savings plans and programs, as they may be adopted. in a 401(a) money purchase retirement plan.

SECTION 3. That Section 2.3.D.5, Tuition Reimbursement, of the Personnel Handbook be amended as follows:

D. Tuition Reimbursement

5. Additionally, employees are required to continue to work for the TPA for one-year following receipt of a tuition reimbursement. Any tuition reimbursement program participant who elects to terminate TPA employment or is terminated due to gross misconduct within one-year of course or program completion shall repay the TPA a pro-rated amount equivalent to the total value of the tuition reimbursement, either directly or through deductions from his or her final paycheck if the balance is sufficient to cover the amount owed, or through a combination thereof.

SECTION 4. That Section 2.4.C.2., Accrual of Sick Leave, of the Personnel Handbook be amended as follows:

C. Sick Leave

2. Employees will be paid for ten (10) percent of accrued sick leave upon termination, provided they leave in good standing. In the event of the death of an employee, payment for one hundred (100) percent of accrued sick leave will be made to the employee's beneficiary, estate, or as provided by law. The effective date of payment of all accrued leave will be issued on the next regular pay date following the pay period in which employment terminated.

SECTION 5. That Section 2.4.K.3., Parental Leave, of the Personnel Handbook be amended as follows:

K. Parental Leave

3. Eligible employees will be granted a maximum of six (6) consecutive weeks of paid parental leave. An eligible employee who is the birthing mother may receive an additional two (2) weeks of paid leave, if it is deemed medically necessary for the birthing mother's physician, by written documentation. To meet certain business needs of the TPA, intermittent use of parental leave may be granted by the Executive Director. In such cases, the intermittent use of parental leave will be limited to five (5) total workdays within the six (6) week period.

SECTION 6. All resolutions, or parts of resolutions or policies otherwise existing that are inconsistent with or in conflict herewith, be and the same are hereby repealed to the extent of such conflict.





Beach TPA's mission and vision statements are intended to be inspirational while also providing a focus and direction for the organization. Together, they guide the Governing Board in making decisions consistent with the established priorities of the TPA.

Several benefits are derived from developing and implementing the Strategic Plan. Governing Board priorities are clearly communicated for the TPA Executive Director and staff to follow. Metrics are established for measuring progress on each action and making adjustments to achieve the strategic outcomes efficiently & cost-effectively. Transparency and accountability are provided to the public, the partnering organizations, and the member agencies of the TPA.





WHEREAS, the FY 26-30 List of Priority Projects has been formally reviewed and recommended for approval by the TPA's advisory committees.

SECTION 2. The TPA Governing Board hereby:



Overview

The Palm Beach Transportation Planning Agency (TPA) Transportation Improvement Program (TIP) for Fiscal Years 2026 through 2030 begins with TPA Board approval of a List of Priority Projects (LOPP). Pursuant to s. 339.175(8), F.S., the TPA must transmit the project list to the Florida Department of Transportation (FDOT) by August 1 of each year to accommodate an accelerated Florida Legislative session schedule. FDOT uses the List of Priority Projects to develop their Five-Year Work Program and the TPA uses the list to develop the TIP.

Existing Priority Projects that have not yet been implemented continue to be shown on the project list. If the lead agency for a Priority Project cannot complete the programmed phase and advance the project to the next logical phase, it is incumbent upon the agency to provide an explanation to the Palm Beach TPA. Changes to the priority list from the previously adopted priority list are underlined in the following tables.

The Priority Projects are divided into three programs: State Road Modifications, Local Initiatives, and Transportation Alternatives. These programs are consistent with the TPA's adopted Long Range Transportation Plan (LRTP) and the funding sources assumed in the financial plan of the LRTP. The TPA Board also adopted Resolution TPA 2015-04 on June 18, 2015 to further clarify the funding expectations for implementation of TPA Priority Projects as summarized below. The resolution noted that Strategic Intermodal System (SIS) Projects identified by FDOT are to be funded primarily with SIS revenue, other minor projects (e.g. local projects, FDOT safety projects, etc.) are to be funded with discretionary resources, and the implementation of these projects shall create no adverse impacts on implementation of TPA Priority Projects.

- Major Projects/State Road Modifications are to be funded with a portion of District Dedicated Revenue (DDR) Funds, DS Funds and State Public Transportation Office (DPTO) Funds. The portion of funding available for Major Projects is expected to be the remaining revenue from these sources after satisfying operations and maintenance requirements, district-managed SIS commitments, and statutory obligations to other modes of transportation.
- <u>Local Initiative Projects</u> are to be funded with the TPA's sub-allocated share of Surface Transportation Program funds (SU) and supplemented with statewide Surface Transportation Program funds (SA) where possible. Some SU and/or SA funds may occasionally be used for State Road Modification projects when state revenues are inadequate to fully fund those projects.
- <u>Transportation Alternative Projects</u> are to be funded with the federal Transportation Alternative (TA) revenue.

The projects in each program are consistent with the Goals, Objectives, and Measures of the LRTP. Eligible projects were evaluated and ranked pursuant to the LRTP and the scoring systems for the individual programs, as applicable. Projects are ordered by the year the project was first prioritized followed by the prioritization in that specific year. For example, 20-1 indicates the year 2020 and the top ranking (first) priority project from 2020.

The TPA prepared the following LOPP that is multimodal in nature and provides overall direction to FDOT in allocating funds. The public involvement process includes presentation and discussion of the project list at meetings open to the public; agendas for these meetings are posted on the TPA website. The LOPP will be reviewed by the Technical Advisory Committee and Citizens Advisory Committee (July 10, 2024), and Vision Zero Advisory Committee (July 11, 2024). The TPA Governing Board is expected to adopt the Annual LOPP at the July 18, 2024 meeting.

Major Projects

Project Selection Process

Larger projects are selected from line-item Cost Feasible projects in the adopted 2045 Long Range Transportation Plan (LRTP). Smaller non-regionally significant projects are identified by TPA staff and stakeholder groups and include State Road Modifications that advance the TPA's vision, Complete Streets policy, and Vision Zero commitment. Projects incorporate safety, complete streets, infrastructure to construct enhanced transit corridors, transportation system management & operations, and environmental resiliency. When possible, this program provides supplemental funding for resurfacing and bridge replacement/rehab projects to advance the objectives noted above.

Project Funding

Major Projects are funded with a portion of:

- State Comprehensive Enhanced Transportation System (SCETS) funds, identified using the District Dedicated Revenue (DDR) fund code, to be expended within Palm Beach County pursuant to s. 206.608(2), F.S.;
- State fuel sales tax funds, including State Primary funds for highways and public transit (DS fund code) and State Public Transportation Office funds (DPTO fund code) to be expended for any legitimate state transportation purpose, with a required minimum for public transportation;
- Highway Safety Improvement Program (HSIP or SS fund codes) funds on identified safety projects; and
- Federal Surface Transportation Program Funds (SU and/or SA fund codes) when state revenues are inadequate to fully fund projects.

Funding available for State Road Modifications is expected to be the remaining revenue from these sources after satisfying operations and maintenance requirements, district-managed SIS commitments, and statutory obligations to other modes of transportation. Projects that are new to the list are typically programmed in the new 5th year – Fiscal Year 2030. Recent increases in costs and limited state funding has increased the amount of SU funding on Major Projects/State Road Modifications that is typically prioritized for the Local Initiatives priorities.

Anticipated 5-YR Funding from LRTP (State Funds Only): ~\$101M (\$20.4M/yr.)

Amount needed to fund all phases of remaining priorities: ~\$277 M

The TPA requests the following for the FY 26-30 Major Projects List:

- **Program state funding instead of SU funding when available** reduce the amount of SU funding programmed towards state roadway projects to program Local Initiatives priorities.
- Tri-Rail extension from West Palm Beach to Jupiter (#14-1): coordinate with TPA on the FDOT-lead studies anticipated to be complete this coming year.
- US-1 enhanced transit service with associated multimodal corridor facilities:
 - Construction funding for complete streets reconstruction project in West Palm Beach (17-1d);
 - Construction funding for complete streets reconstruction project in North Palm Beach (17-1f);
 - Design funding for lane repurposing project in Lake Worth Beach (priority #17-1g), pending FDOT approval of design.
- **US-27 Connector from US-27 to SR-715** Program the Project Development and Environmental (PD&E) phase, accelerated with state funding if available.
- Lake Worth Rd enhanced transit service with associated multimodal corridor facilities (20-1): The TPA requests funding of transit signal prioritization to coincide with the transit signal prioritization on US 1 and Okeechobee Blvd.
- Federal Hwy at Spanish River Blvd (#20-1): The TPA requests construction funding.
- Traffic Signal Improvements: The TPA requests construction funding for traffic signal upgrades and supporting infrastructure for Palm Beach County and City of Boca Raton signals, including priority projects 20-2, 20-3, and 20-4.
- Indiantown Rd at Central Blvd PD&E (#21-6): The TPA requests accelerated funding of the PD&E to evaluate congestion mitigation alternatives.
- 2023 priorities #23-1, #23-2, and #23-3: The TPA requests FDOT consider programming preliminary engineering (PE).

Table 1: Major Projects

Projects are predominantly on state roadways using state funding sources, including but not limited to District Dedicated Revenue (DDR) and Primary Highways & Public Transportation Funds (DS).

Projected funding availability is anticipated to be approximately \$20.4 Million/year but varies yearly. FDOT requests the TPA "oversubscribe" to ensure programming of all available funds.

Local Initiatives Projects

Project Selection Process

The Local Initiatives Program was created in the 2040 LRTP and is structured to identify and fund non-regionally significant transportation projects off the state highway system. Local Initiative projects are selected from an annual competitive application process based on the Goals, Objectives, and Measures in the adopted LRTP; these projects are then approved by the advisory committees and the TPA Board. Applications for Local Initiative projects were solicited from transportation service providers, county, and municipal staff.

Project Funding

These projects are primarily funded through federal Surface Transportation Program Funds, locally known as SU funds, sub-allocated to the Palm Beach TPA. The TPA receives approximately \$22.8 million per year. Approximately \$2.5 million is programmed towards TPA planning activities. Projects new to the list are typically programmed in the new 5th year – Fiscal Year 2029.

Anticipated 5-YR Funding from LRTP available for projects: ~\$114M (\$22.8 M/yr.) - may also be used on Major Projects/State Road priorities

Amount needed to fund all phases of remaining priorities: ~\$22.95 M

The TPA requests the following for the FY 24-29 Local Initiative Priority Project List:

- Update programming of SU funding to support TPA planning and administration consistent with the FY 25-26 UPWP.
- 2023 Local Initiatives Priorities: Program 2023 priorities from the 2023 call for projects.

Project Selection Process

Transportation Alternatives (TA) projects are selected from an annual competitive application process based on the Goals, Objectives, and Measures in the adopted LRTP.

Project Funding

Construction of TA Projects proposed for inclusion in the TIP is funded with federal Surface Transportation Block Grant (STBG) Transportation Alternative (TA) set-aside funds on a cost reimbursement basis for eligible expenses and supplemented with local funds. Funding levels are anticipated at \$5.1M/yr. Design of the project is funded by the applicant no less than two years prior to construction funding availability. Projects that are new to the list are typically programmed in the 3rd year – Fiscal Year 2028.

Anticipated 3-Year Funding Level from LRTP: ~\$15.3M (\$5.1M/yr.)

Amount needed to fund all phases of remaining priorities: ~\$5.089

- Functional Classification (Funclass) is a method to describe the usage of roadways within the immediate area, regionally for some roadways and statewide for others.
- Federal Highway Administration requires roadways to be functionally classified as part of the mechanism to <u>fund</u> <u>roadway improvements</u> and perform analysis of the network of roadways.







Overview

- Federal-aid Eligibility is determined by Functional Classification which includes roadways higher than Local or Rural Minor Collector.
- Surface Transportation Block Grant (STBG) funds are used on Federal-aid roadways.
- Federal Highway-Emergency Relief (FHWA-ER) are used after a disaster declaration (e.g., hurricane, floods, tornados,...)





Functional Classification

Roles

- FDOT performs initial review and determination of Funclass.
- City and County agencies review Funclass within and adjacent to their boundaries providing concurrence or recommendations for Funclass of roadways.
- MPO/TPO/TPA approve the Funclass by signing the official maps.
- FDOT & FHWA approve the Funclass by signing the official maps.

The TPA conducted a planning study for an extension for Tri-Rail to the VA Medical Center in West Palm Beach. A feasibility study is now recommended for the project, which was covered by the Palm Beach Post.

Review of Scope with Agency	Meet with local agency to review and confirm scope prior to FDOT advertising for consultant acquisition.
Execution Date (Design)	FDOT Design starts.
Project Kickoff Meeting	FDOT Design Team coordinates with local agency. Contact the FDOT project manager for date/time/location of the meeting.
Initial Field Review	Field Review meeting. Typically occurs at the project site.
Initial Engineering	30% plans to reviewers. Stakeholders provide review and feedback on the approved Typical Section.
Public Information Workshop	Tentative date to conduct a public information workshop. Date may differ than final workshop date.
Constructability Plans	60% plans to reviewers. At this time most of the Design is complete, no scope discussion, review focuses on items to be constructed, their construction impacts, and materials to be used.
Plans Specification and Estimates (PSE) Meeting	FDOT PM arranges field review with all reviewers to evaluate the final engineering plans with respect to actual field conditions.
Biddability Plans to Reviewers	90% plans. At this time, Design is complete. Verifying quantities and pay items.
Production	100% plans. Plans are complete.
Local Agency Program (LAP) Commitment	Agency and FDOT commits the project funds and budget to the Legislature and the Governor's office.
Letting	Bids are opened and the apparent low bid contract is determined. Construction typically begins 4 to 6 months after letting.
Construction Notice to Proceed (NTP)	Construction starts. Construction dates for FDOT administered projects can be found through the FDOT Operations Center.
