### 2. ACTION ITEMS

# 2.A. <u>MOTION TO RECOMMEND ADOPTION</u> of Amendment #1 to the TPA's Fiscal Year (FY) 25-29 Transportation Improvement Program (TIP)

ANDREW UHLIR, Deputy Director of Programs, provided a presentation.

JIM KNIGHT asked if funding for the Brightline Station project will be rolled forward for the parking garage or allocated from a separate funding source. He requested that staff send him the correct funding information. TPA staff confirmed they will provide an update once available.

MYRON UMAN acknowledged the General Appropriation Act projects and asked whether the call for projects goes through a formal project prioritization process.

ANDREW UHLIR replied that there is a formal application that is submitted to the legislature. However, the projects are not vetted by FDOT prior to submit and their programming can sometimes be difficult for FDOT as they are required to rebalance the FDOT work program statewide.

### 3. INFORMATION ITEMS

### 3.A. Transportation Demand Management Programs

BRIAN RUSCHER, Deputy Director of Multimodal, AND Jonathan Hopkins of WPB Go and Jeremy Mullings of South Florida Commuter Services, provided a presentation.

JIM KNIGHT asked how much notice is needed before receiving the transportation services.

JEREMY MULLINGS replied that they operated through midnight and after the pilot program, they will operate 24/7.

VIJAY MISHRA shared a similar program and their process and incentives.

JONATHAN explained their goal as an employee would not be competitive.

MYRON UMAN asked if staggered working hours, in which different employers operate with different starting times to smooth out rush hours, were considered.

UYEN DANG guestioned how the mobility wallet works within the program.

JONATHAN HOPKINS provided an example and explained that WPBgo pays a certain amount of money for Tri-Rail and people who qualify can get a month pass or a 12-month pass.

CHAIR GARVIN noted his support for the pilot program.

KATE LAYTON shared a bicycle charity and shop know as Jack the Bike Man, Inc.

### 3.B. Speed Management Study Update

VALENTINA FACUSE, Pedestrian and Bicycle Planner, and Spencer Maddox, Engineer with Kittleson and Associates, provided a presentation.

LILY-CHARLOTTE LANDSTROM suggested staff conduct outreach for high injury roads and asked if education was available to the public regarding roadway safety.

UYEN DANG noted the committee supports speed reductions and tool management but questioned how those tools and coordination would be applied to the County roads.

CHAIR GARVIN asked if there are any obligations for the Municipalities to proceed in the next steps.

UYEN DANG expressed her concern regarding a second draft study.

SPENCER MADDOX stated it is standard practice to conduct the speed management study.
