3.A. Vision 2050 Long Range Transportation Plan (LRTP) Draft

ANDREW UHLIR, Deputy Director of Programs and Stewart Robertson, Kimley-Horn and Associates, Inc. representative, provided a presentation.

MYRON UMAN asked staff to highlight some of the larger projects and items that are new to the 2050 LRTP.

STEWART ROBERTSON stated Technology solutions, complete streets, investment in identifying transit solutions, and supporting roadway grid networks.

ANDREW UHLIR noted the major national highway and infrastructure improvements by FDOT, studies for grade separation for the rail line, and feasibility studies for resilience.

BRIAN RUSCHER noted the LRTP provides short-and long-term improvements for transit.

BRIAN ROSEN asked if staff could share the project list in the LRTP through excel sheets for efficiency purposes.

UYEN DANG asked how the agency plans to implement transit signal prioritization Brian Ruscher and Stewart Robertson summarized the different signal pre-emptions for both emergency vehicles and transit vehicles.
