










The Timeline





Role of the Long Range Transportation Plan

The transportation plan shall include both long-range and short-range strategies/actions that provide for the development of an integrated multimodal transportation system (including accessible pedestrian walkways and bicycle transportation facilities) to facilitate the safe and efficient movement of people and goods in addressing current and future transportation demand. 23 CFR 450.324(b)


At this time, which of the following would you say should be the highest priority for county leaders? Is it...













Which would you say should be the highest priority transportation planning?












Employer-Household Dynamics (LEHD) 2017 data

A Strategic Approach

The following categories of strategies, or combinations of strategies, are some examples of what should be appropriately considered for each area:


(i) Demand management measures, including growth management, and congestion pricing;

- (ii) Traffic operational improvements;
- (iii) Public transportation improvements;
- (iv) ITS technologies as related to the regional ITS architecture; and

(v) Where necessary, additional system capacity.

23 CFR 450.322(d)(4)

The Role of Policy



TPA's Goals, Objectives and Strategies are framed in BROAD terms to:

- serve TPA's diverse stakeholders
- avoid de-emphasis by omission

Goal: Safe

<u>Objective S.1</u>: Eliminate transportation related serious injuries and fatalities.

Strategy S.1a: Implement the TPA Vision Zero Action Plan and Complete Streets Policy.

<u>Strategy S.1b</u>: Identify and prioritize projects on the High Injury Network.

<u>Strategy S.1c</u>: Address transportation barriers in historically disadvantaged communities.

<u>Strategy S.1d</u>: Leverage innovation and technology with demonstrated safety benefits.

<u>Objective S.2</u>: Support regional adoption of safety policies and plans.

<u>Strategy S.2a</u>: Establish and implement Vision Zero and Complete Streets policies & plans. <u>Strategy S.2b</u>: Utilize a Safe System decision-making framework in planning & design.

<u>Objective S.3</u>: Support emergency management functions including evacuation, response, and post-disaster recovery.

<u>Strategy S.3a</u>: Consider projects that maintain or enhance evacuation routes.

<u>Objective S.4</u>: Enhance the safety and security of transit, rail, and other multimodal facilities. <u>Strategy S.4a</u>: Improve existing rail grade crossings with a crash history.

Strategy S.4b: Improve bus terminals and stop areas.

<u>Strategy S.4c</u>: Develop microtransit and mobility hubs throughout the county.


