- A. MOTION TO ADOPT 2025 Safety Targets
- Pursuant to the Federal Highway Administration (FHWA), the TPA is required to adopt targets for federal performance measures. Roadway safety targets are required to be adopted annually and include the number and rate of traffic-related fatalities and serious injuries, and number of pedestrian & bicycle fatalities and serious injuries.
- Since 2018, the TPA Board has adopted the State's roadway safety targets of zero (0) traffic-related fatalities and serious injuries. TPA staff recommends adoption of the State's roadway safety targets and will provide a presentation to review the attached TPA draft resolution establishing the 2025 Safety Targets.
- B. MOTION TO ADOPT Amendment #2 to the FY 2025-2029 Transportation Improvement Program (TIP)

MARCI WOODWARD announced that the Board of County Commissioners issued a Transportation Master Plan Request for Proposals (RFP) and an upcoming meeting with FDOT, City of Delray Beach, and Palm Beach County Engineering Department regarding Atlantic Avenue plans.

GLEN SPIRITIS thanked Valerie Neilson and the TPA staff for meeting with the City of Riviera Beach.

JEFF HMARA noted his recent meeting with Palm Tran's Executive Director to discuss their voucher programs and Bus Link services.

YVETTE DRUCKER expressed appreciation to Valerie Neilson and the TPA staff for their help. She also noted that Boca Raton Airport is expected to experience higher air traffic due to the new administration.

CHAIR REED stated that the City of Palm Beach Gardens will start preparing for Burns Road construction to develop a two-way cycle track and improve pedestrian infrastructure.

YVETTE DRUCKER, CHRISTY FOX, and MICHAEL NAPOLEONE were elected 2025 TPA Board Officers.

**2.B. MOTION TO ADOPT the 2050 Long Range Transportation Plan (LRTP)**

STEWART ROBERTSON, Kimley-Horn Associates, Inc. representative, provided a presentation.

PIA SKORAN submitted a public comment and voiced concerns about the proposed traffic plans for the Acreage and the additional traffic they would bring. She suggested working with the City of West Palm Beach to extend State Road 7 to Northlake Blvd. to eliminate traffic on local roads.

WILLIAM DERKS submitted a public comment and voiced concerns about the proposed traffic plan, suggesting the main arterial roads be opened to ease congestion on local roads. He also asked board members to oppose the proposal to extend Okeechobee Blvd. along State Road 80.

BEN BROWN submitted a public comment and asked for an update on the Okeechobee Blvd. extension project and stressed the urgency of completing it due to the increase in crashes in Arden.

NINA CORNING submitted a public comment and expressed concerns about the negative impact the traffic plan for the Acreage could have on their neighborhood.

JIM KURETSKI stated that he will vote against the 2050 LRTP, because, despite the 2019 FDOT congestion study of Palm Beach County identifying Indiantown Road as the most congested, the proposed roadway modifications were not included in the Cost Feasible List.

SARA BAXTER requested an update on the State Road 7 project status.

MICHAEL NAPOLEONE thanked the residents of the western communities for their public comments and emphasized the need for the State Road 7 project for public safety and roadway network connectivity.

GLEN SPIRITIS stated his intention to vote for the 2050 LRTP and noted that new development along US-1 / Broadway in Riviera Beach.

JEFF HMARA noted the 2050 LRTP will inform the Countywide Master Transportation Plan, allowing for new alternatives and promoting mass transit in areas that were not previously considered.

STEVE WILSON expressed his support for the 2050 LRTP and asked what the course of action would be if the court ruling opposes the State Road 7 expansion.

MARIA MARINO noted the County Transportation Plan is a global perspective and urged all 39 municipalities to assess their future needs and collaborate.

MARCI WOODWARD inquired about how often the plan is updated to reflect current traffic needs and whether priority projects can be re-ranked.

SARA BAXTER emphasized State Road 7 is essential for reducing traffic congestion, making it a priority.

Under the Department of Engineering and Public Works, the Traffic Division is charged with installation, operation, and maintenance of traffic control devices, including traffic signals, flashers, road signs, street lights, and pavement marking. The Division operates and maintains 1,200 signals and flashers throughout Palm Beach County with the exception of the City of Boca Raton and Town of Palm Beach. The Traffic Division also operates and maintains about 500 signals and flashers as well as 4,000 streetlights on the State Highway System (SHS) under compensation agreements with the Florida Department of Transportation (FDOT). - G. Florida's Open Meetings Law - Every CAC Member shall comply with the State's Open Meetings Law. This includes not discussing current agenda items or other matters that may foreseeably come before the CAC for action with other CAC Members outside of a noticed meeting.

## **Section 5. Vision Zero Advisory Committee (VZAC)**

### **5.1 Role and Function**

The VZAC serves in an advisory capacity to the TPA Governing Board to advance those elements of the TPA's Vision Zero Action Plan oriented around pedestrian and bicycle safety, and to address other matters and concerns when directed by the TPA. It shall be the function of the VZAC to review and make recommendations to the TPA Governing Board regarding the non-motorized elements of:

- Objective Scoring system used to rank project applications submitted for funding through the annual Transportation Alternatives Program.
- The TPA's Long Range Transportation Plans (LRTP), Priority Project Lists, Transportation Improvement Programs (TIP), and Unified Planning Work Programs (UPWP);
- Other TPA-led transportation plans, studies and reports;
- Transportation plans, studies, reports, and project designs presented to the TPA by partner agencies (FDOT, PBC Engineering, Municipalities, SFRTA, Palm Tran, Seaport, Airport, etc.);
- Regional transportation plans, studies, reports, and projects; and
- Other items of interest as determine by the TPA or the VZAC.

### **5.2 Membership**

- A. Number of VZAC Members - ~~The VZAC is comprised of up to twenty-one (21) members as The number VZAC Members for the TPA shall be determined by the TPA Governing Board.~~ An agency seeking membership on the VZAC shall submit a written request to the TPA for consideration and approval by the TPA Governing Board. The TPA Governing Board has final approval of membership. If FDOT seeks a ~~seat membership~~ on the VZAC their Representative and Alternate would serve as a non-voting advisor. The membership of the VZAC shall include representatives of local governments, law enforcement and fire rescues services, school district, health department, active transportation advocacy groups, and other entities as deemed appropriate by the TPA Board to advance those elements of the TPA's Vision Zero Action Plan oriented around pedestrian and bicycle safety.
- B. VZAC Representatives - Each VZAC Member shall nominate a VZAC Representative by submitting a written nomination and a description of the individual's credentials to the TPA for consideration and approval by the TPA Governing Board. No advisory committee Representative may serve on more than one advisory committee to the TPA Governing Board at any time.
- C. VZAC Alternates - Each VZAC Member may nominate a VZAC Alternate with a description of the individual's credentials and submit the nomination in writing to the TPA for consideration and

**WHEREAS**, the Federal Highway Administration (FHWA) performance measure implementation requires the Palm Beach Metropolitan Planning Organization (MPO), doing business as the Palm Beach Transportation Planning Agency (TPA), to adopt federal Safety Targets by February of each year;

**WHEREAS**, the required federal safety performance measures include the number and rate of fatalities, the number and rate of serious injuries, and the number of pedestrian & bicycle fatalities and serious injuries;

**WHEREAS**, the TPA has the option to support the safety targets adopted by the State, or establish their own targets; and

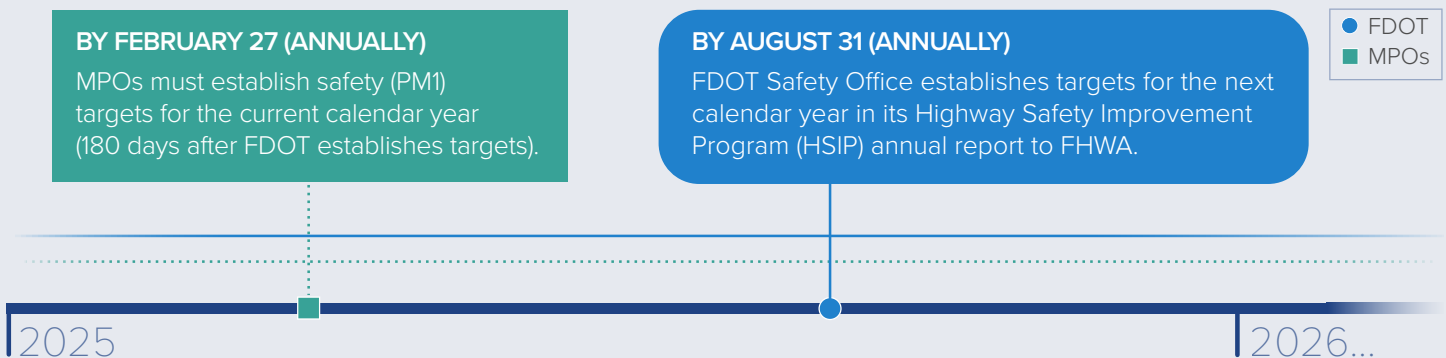

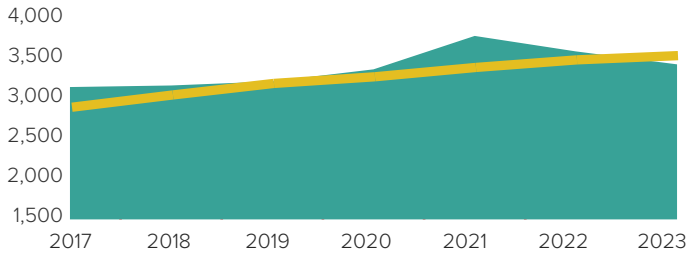

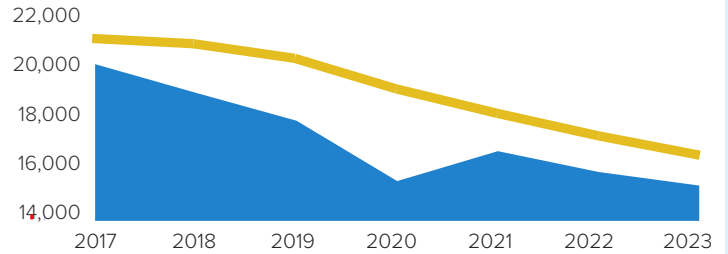

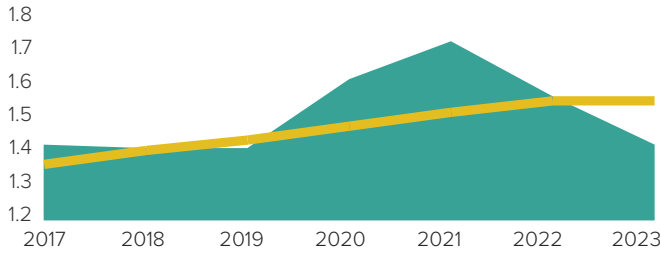

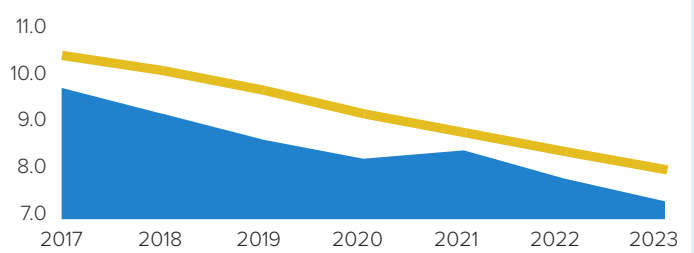
## ANNUAL SERIOUS INJURIES



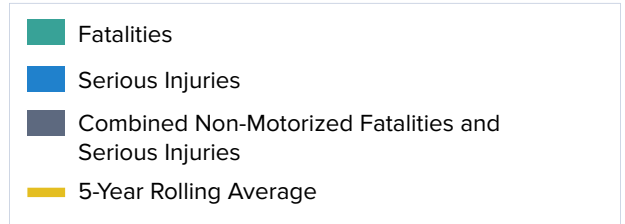
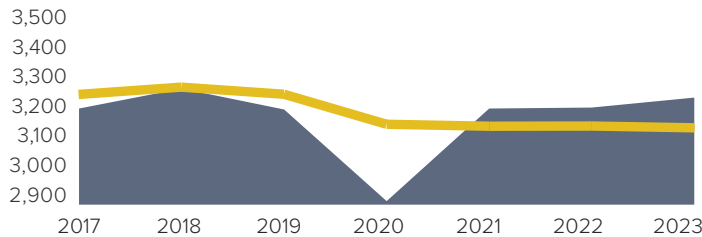
## FATALITY RATE (PER HUNDRED MILLION VMT)

## STATEWIDE TARGETS

FDOT establishes statewide safety targets for the following calendar year as part of the [HSIP Annual Report](#), which must be submitted by August 31 each year.

Given FDOT's firm belief that every life counts, the target set for all safety performance measures is ZERO.

## MPO TARGETS

MPOs must set targets by February 27 of each year (within 180 days after FDOT sets targets). MPOs have the option of supporting the statewide targets or establishing their own targets for the MPO planning area.

MPOs must include the most recent reported performance and targets with each TIP update. The TIP must describe how the investments contribute to achieving the performance targets. The LRTP must include a System Performance Report that discusses the performance of the transportation system and progress achieved in meeting the targets over time.

## ASSESSMENT OF SIGNIFICANT PROGRESS

FHWA considers a state to have met or made significant progress when at least four of the five safety targets are met or the actual outcome is better than baseline performance. Florida is making progress towards achieving the targets established for serious injuries but not yet for fatalities or non-motorized users.

As requested by FHWA, FDOT annually develops an [HSIP Implementation Plan](#) to highlight strategies it will undertake in support of these targets. MPOs are encouraged to review this Plan each year to identify strategies appropriate for their planning area.

FHWA will not assess MPO target achievement. However, FHWA will review MPO adherence to performance management requirements as part of periodic transportation planning process reviews.

## **FY 2024 Annual Listing of Obligated Project Summary**

Both 23 USC §134 and §339.175, Florida Statutes, mandate that Metropolitan Planning Organizations (MPO) publish the annual listing of projects for which federal funds have been obligated in the preceding year. 23 CFR §450.334 further stipulates that the listing shall identify for each project the amount of Federal funds requested in the TIP, the Federal funding that was obligated during the preceding year, and the Federal funding remaining and available for subsequent years.

The Palm Beach TPA created the attached summary listing of projects where total Federal funding requested in the TIP differed from the Federal funding that was obligated. Notes are included for projects with variations greater than \$1 million.

In general, federal funds are obligated to transportation projects through the Federal Highway Administration (FHWA) and Federal Transit Administration (FTA). According to FHWA definition, an obligation is a legal commitment: the Federal government's promise to pay a State for the Federal share of a project's eligible cost. For a project funded by FHWA funds, this commitment occurs when FHWA approves the project and executes the project agreement. For a project funded by FTA funds, this commitment occurs at the time the FTA grant is awarded. Alternatively, funding can also be "de-obligated". A de-obligation means money previously obligated is removed from the project to reflect changes to the project cost, delay, or cancellation.

WPTV spoke to Palm Beach County Fire Marshall Chief Dave DeRita about dirtbike and e-bike safety on the roads.



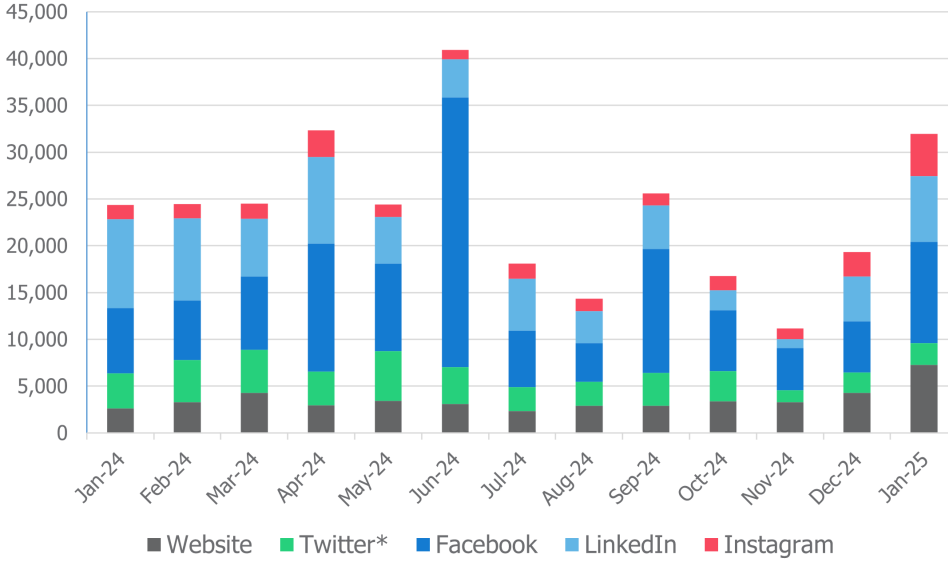

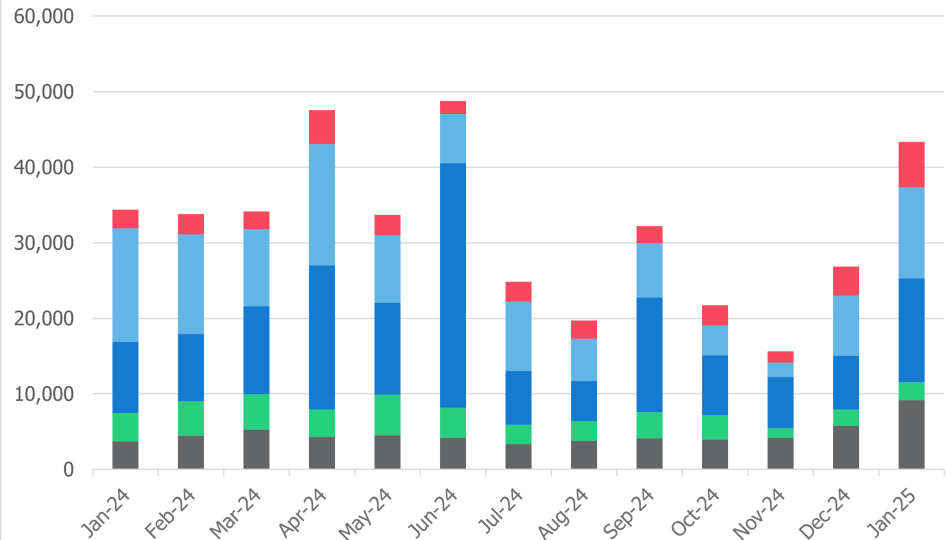

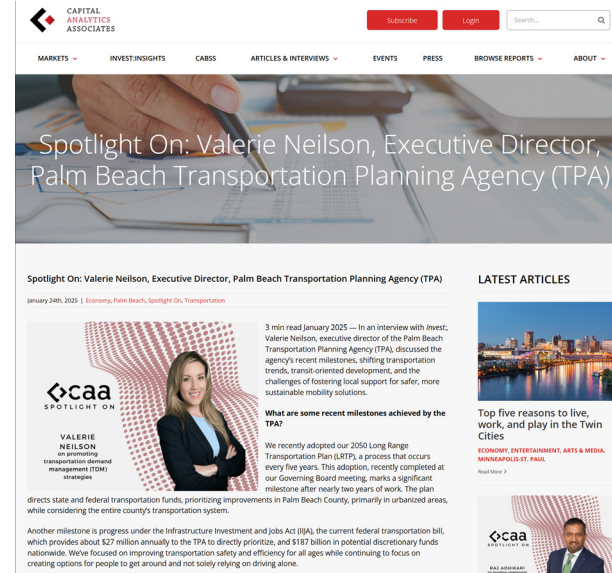
