A. Draft Fiscal Year (FY) 2026 – 2030 Transportation Improvement Program (TIP)

The TIP is the five-year funding program for transportation projects in Palm Beach County. This program was developed in collaboration with the Florida Department of Transportation (FDOT) and various local agencies and includes transportation projects funded by federal and state sources for all modes of transportation. The TIP reflects revenue expectations for the next five fiscal years and programs projects by phase, year, and funding source.

This is the first review of the TIP. The final adoption is scheduled for the TPA Governing Board meeting on June 26, 2025.

The draft executive summary for the FY 2026-2030 TIP is attached. The full TIP document, interactive TIP tool, and appendices can be viewed at PalmBeachTPA.org/TIP.
