FADI NASSAR expressed his appreciation for the recently installed pump track in Okeeheelee Park.

### 3.A. Draft Fiscal Year (FY) 2026-2030 Transportation Improvement Program (TIP)

BRIAN RUSCHER, Deputy Director of Multimodal, provided a presentation.

There were no public comments received.

FADI NASSAR inquired whether Broadway will be lane repurposing. TPA staff confirmed it is not a lane repurposing project. He also requested a presentation from the Turnpike to the committee.

CHAIR THOBURN questioned the limits of the Shared Use Nonmotorized Trail Project in Jupiter and noted that Jupiter utilizes the TIP to connect boundaries within nearby communities.

## 3.B. FDOT District 4 Pedestrian and Bicycle Master Plan Update

CORINN BEAM, FDOT Consultant, provided a presentation.

There were no public comments received.

TRACY PHELPS inquired about separated bike lanes on FDOT Roadways. The FDOT replied that they are updating the bike master plan and will provide the findings once it is complete.

FADI NASSAR asked about the tradeoffs for using e-bikes and scooters on bike lanes or wide sidewalks.

## 3.C. Safe Streets and Roads for All (SS4A) Update

BRIAN RUSCHER, Deputy Director of Multimodal, showed the status tracker and led a discussion.

There were no public comments received.

FADI NASSAR noted they are creating an HIN Network and are conducting outreach and individual meetings with stakeholders. They mentioned they are awaiting an additional agreement from FHWA. CLINTON WILLIAMS stated that the consultant selection process will close in May.

JOANN SKARIA stated that Palm Beach Gardens is expected to be completed by June.

TRACY PHELPS noted that the City of Boca Raton should be completed in the summer.
