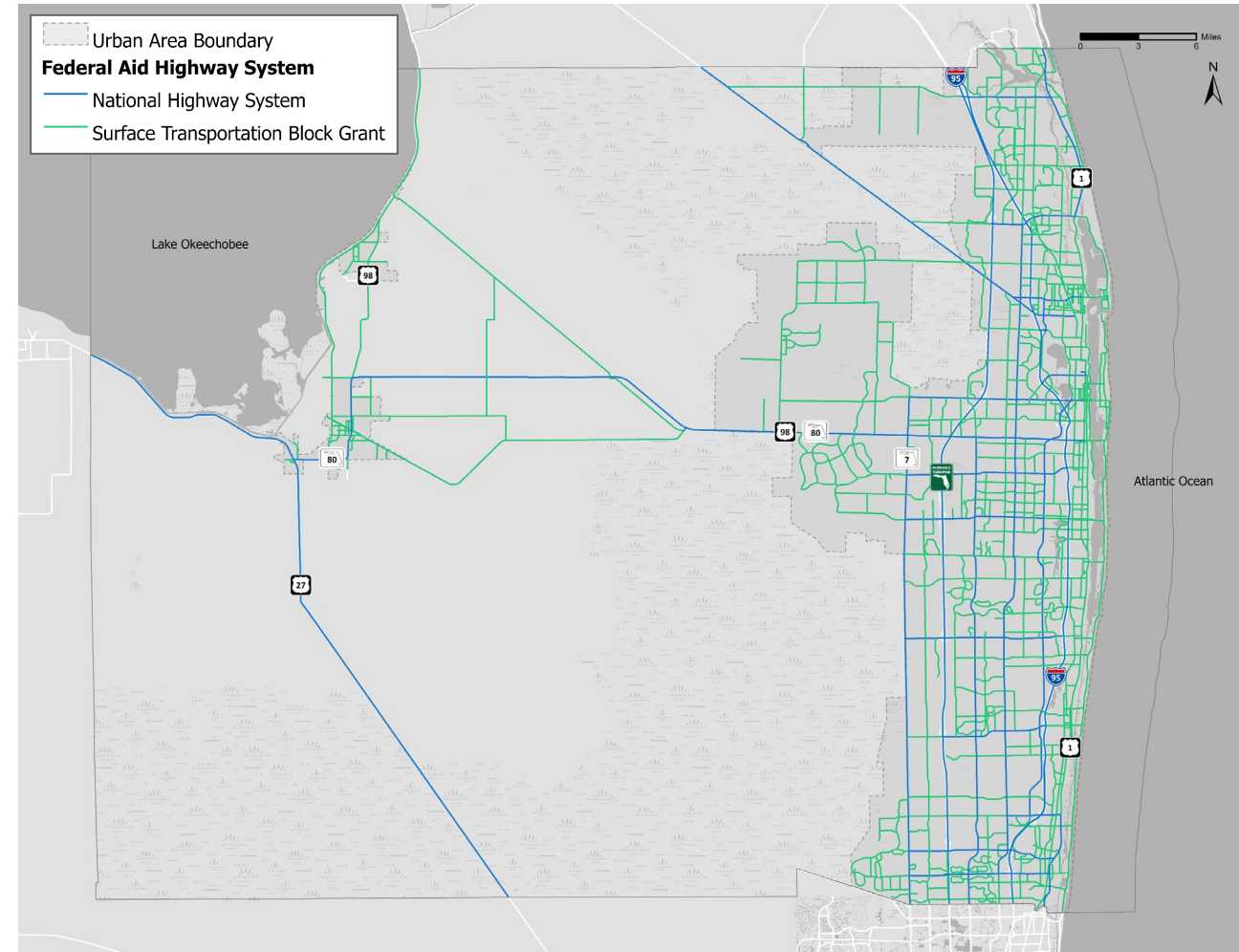

- Plan, prioritize, and fund the state and federal system in an urbanized area
- 25-year transportation system vision
- Public participation in transportation planning decisions

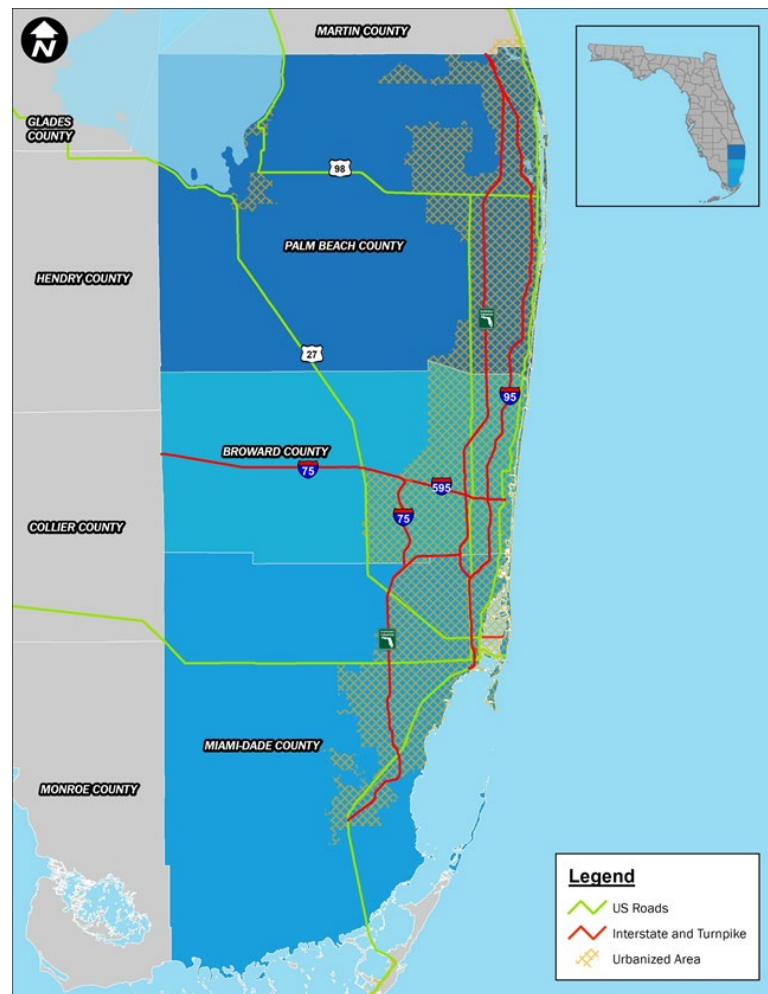
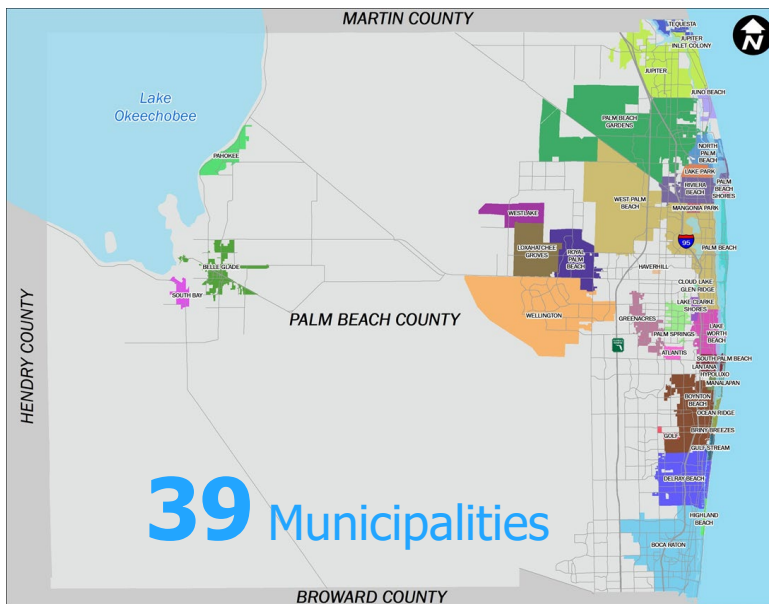
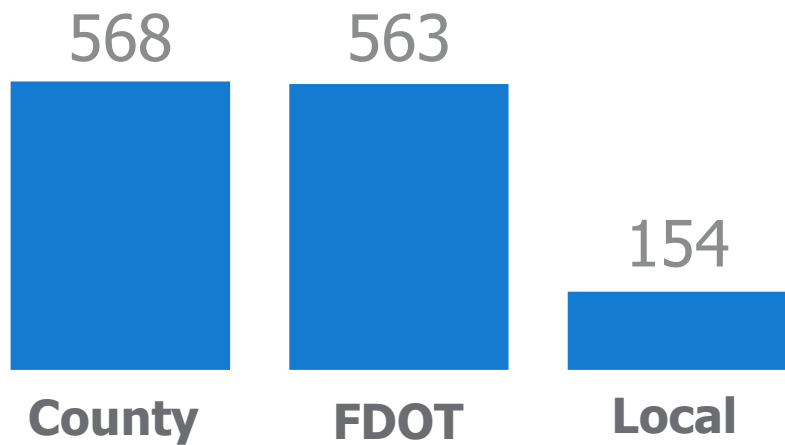
1964 Road Map, Florida



TPA Advisory Committees & TD LCB

- **Technical Advisory Committee (TAC)**
Provides technical review of transportation
- **Citizens Advisory Committee (CAC)**
Provides a citizens' review of transportation
- **Vision Zero Advisory Committee (VZAC)**
Advances TPA's Vision Zero Action Plan and advises on pedestrian and bicycle safety
- **Transportation Disadvantaged Local Coordinating Board (TD LCB)**
Evaluates and plans local Paratransit Service



TPA Board, Advisory Committees, and TD LCB are subject to the Florida Sunshine Law

Citizens Advisory Committee (CAC)

Provides a citizens' review of transportation

- Reviews and provides recommendations on transportation plans, programs, and studies.
- Reflect a broad cross-section of residents with an interest in the development of an efficient, safe, and cost-effective transportation system per Section 339.175(8)1., F.S.

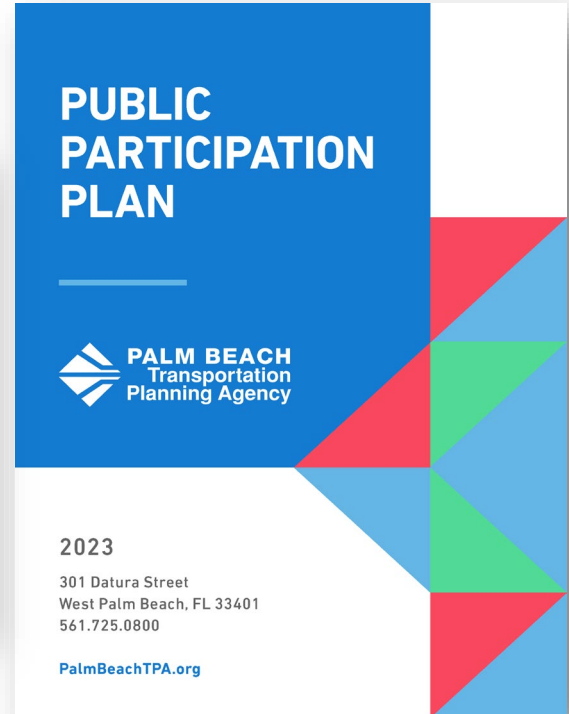

Unified Planning Work Program (UPWP)

- 2-Year Federal MPO Planning Grant
- Agency Operational Plan & Budget
July 2024 to June 2026
- Includes tasks and identifies:
 - Budget and funding sources
 - Staff and/or consultants
 - Deliverables
 - Completion dates

Long Range Transportation Plan (LRTP)

- 25-year horizon, updated every 5-years
- Goals, objectives, performance measures
- Forecast of growth and development
- Transportations needs for all modes
- Revenue forecast and funding

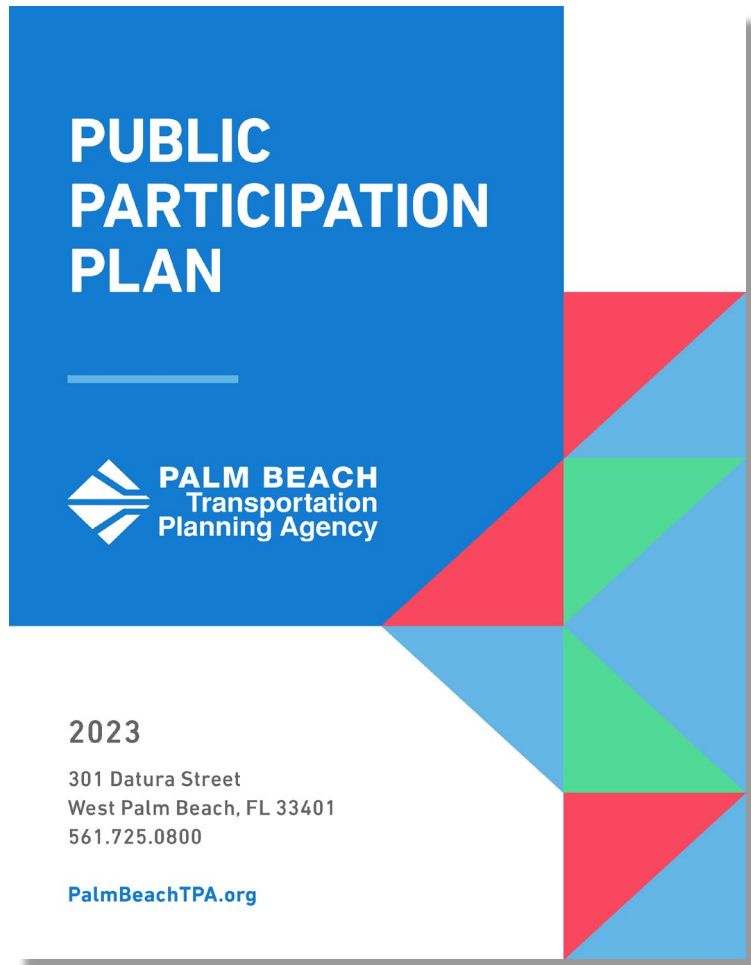


Transportation Improvement Program (TIP)



- List of Priority Projects (LOPP) submitted before TIP
- Updated annually with a 5-year horizon
- Consistent with the LRTP, FDOT Work Program, and local plans
- Projects must be in the TIP to receive federal funds

Public Participation Plan (PPP)



- Establishes public engagement & input processes
- Provides public comment methods and official notice process for required core products
- Updated as needed

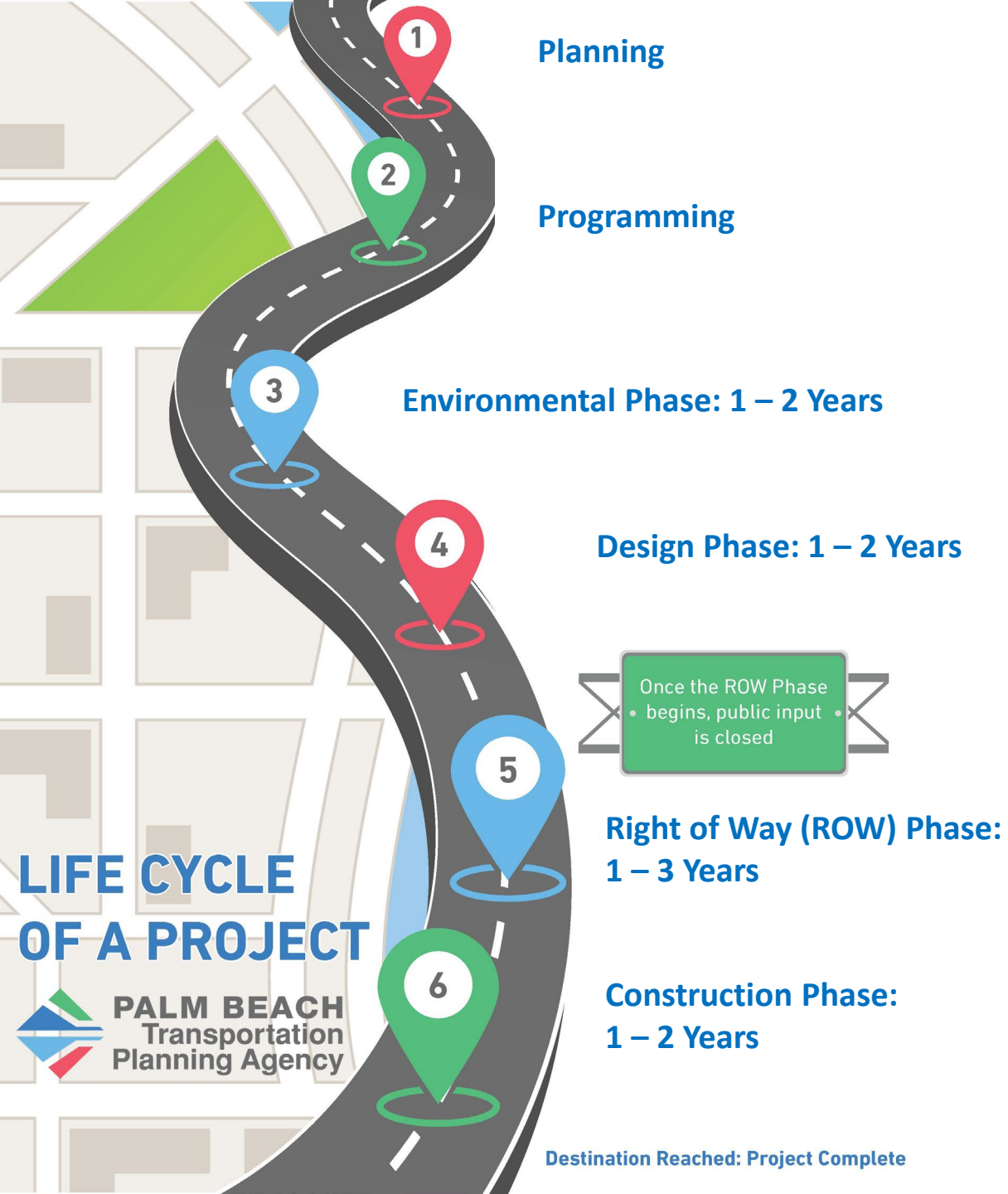
