## **Purpose and Overview**

The Palm Beach Transportation Planning Agency's (TPA) Public Involvement Plan (PIP) guides public participation regarding the TPA's Long Range Transportation Plan (LRTP), known as Vision 2050. The TPA's goal for public participation is to enable and encourage public awareness and input in the planning and prioritization process. The PIP provides a blueprint for the TPA to gather and consolidate public comments on the plan, recommendations, and potential projects within the plan, which may be adjusted as the LRTP is amended to ensure optimum public input and feedback. The PIP generally details when, who, and how information is gathered within the county and region and guides TPA staff on how to evaluate the success of public outreach. This is consistent with the objectives of the TPA's broader Public Participation Plan (PPP), which establishes various strategies to achieve the goal of successful public participation and engagement within the following objectives:

- Use regularly scheduled meetings of the TPA Governing Board, advisory committees (including sub or ad hoc committees), and the Transportation Disadvantaged Local Coordinating Board as opportunities to inform, involve, and seek input from the public.
- Provide comprehensive coverage of business conducted at meetings.
- Use an array of strategies to engage the community, focusing on geographic and demographic diversity and inclusion of traditionally underrepresented populations.
- Continuously evaluate effectiveness of outreach strategies.
- Provide notice and opportunities for public understanding and reviewing of TPA draft documents and proposed amendments. Provide and promote multiple opportunities for public comment.
- Promote and ensure access to traditionally underrepresented groups and communities, including low-income, minority, elderly, transportation disadvantaged, and those with limited English proficiency.
- Plan, promote, and support public participation in the planning and prioritizing of transportation plans and issues concerning Palm Beach County and the Southeast Florida region.

## **Planning Area and TPA Responsibilities**

The Palm Beach TPA is a federally-mandated public agency that works with partners across Palm Beach County, Florida and the region. The TPA's mission is to plan, prioritize and fund the transportation system with a vision of a safe, efficient and connected multimodal transportation system for users of all ages and abilities.

The TPA directs federal and state funds in the urban areas of Palm Beach County and consists of a 21-member Governing Board. The Board approves roughly \$300 million of federal and state transportation dollars each year to implement projects that advance our regional vision for the nearly 1.5 million Palm Beach County residents. Palm Beach County is part of the Miami Urbanized Area. As such, the TPA coordinates with the Broward Metropolitan Planning Organization (MPO) and Miami-Dade Transportation Planning Organization (TPO) in regional planning efforts. This





includes the Southeast Florida Transportation Council, which oversees regional transportation planning through the tri-county MPOs.

The Planning Area of the TPA is the entirety of Palm Beach County, including the Miami Urbanized Area, the Belle Glade and Pahokee urban areas, and the full remaining rural portions of the County.

#### The TPA:

- is responsible for transportation planning for the entire county
- directs federal & state funds in the urban areas
- is a part of the Miami-Ft Lauderdale-West Palm Beach urban area that is coordinated through the Southeast Florida Transportation Council (SEFTC), a collaboration between the Miami-Dade TPO, Broward MPO and Palm Beach TPA

## The TPA Team and Regional Partnerships

In order to achieve the detailed objectives in the PIP, stakeholders must be identified with a jurisdictional, direct, or other interest in Vision 2050. Regular coordination with local governments, as well as regional and state agencies, enables and encourages comprehensive public awareness and input. Key stakeholders include representatives of the following entities:

**TPA Governing Board**: The TPA Governing Board is comprised of 21 locally elected officials – 15 elected officials from our 13 largest municipalities, five of our seven Palm Beach County Commissioners, and one Port of Palm Beach Commissioner. The Board approves the TPA's core work products and provides direction for agency staff.

**Technical Advisory Committee**: The Technical Advisory Committee (TAC) is made up of technical staff representing the various local governments within Palm Beach County, primarily planners and engineers. Members provide technical review, comments, and recommendations regarding items to be considered by the Governing Board, including transportation plans, programs, studies, and other appropriate documents and regional transportation issues.

**Citizens Advisory Committee**: The Citizens Advisory Committee (CAC) is responsible for providing the TPA Board with a "citizen's eye" view of ongoing transportation issues in Palm Beach County. Because one of the core missions of the TPA is to gather local input and desires for transportation within the county, this committee is an important conduit for serving these public interests and submitting their views and concerns to the TPA Board.

**Vision Zero Advisory Committee**: The TPA's Vision Zero Advisory Committee (VZAC) serves in an advisory capacity to the Governing Board mainly to advance elements of the TPA's Vision Zero Action Plan oriented around pedestrian and bicycle safety. VZAC is a mix of technical and civilian members who provide important input on safety and address key concerns within the county.

**Southeast Florida Transportation Council**: The Southeast Florida Transportation Council (SEFTC) is a formal partnership between the Palm Beach, Broward, and Miami-Dade metropolitan planning organizations (MPOs) to coordinate regional transportation planning for all travel modes.





Federally, our three counties are recognized as "one traveling public", making this partnership is an essential tool for public participation and engagement. SEFTC is made up of representatives of each MPO Board and serves as a formal forum for policy coordination and communication. The SEFTC contains the Regional Transportation Technical Advisory Committee, a staff-level advisory committee and three staff-level subcommittees that inform the council on modeling, public participation and transportation system management and operations. The council's mission is to coordinate regional transportation goals, needs, funding, and policies that support the economic health and quality of life of the region.

## **Objectives for Public Participation**

- Community Engagement Strategies
- Continuous Involvement The TPA will offer public meetings and workshops to gather input for Vision 2050 in various geographical parts of Palm Beach County both in- person and virtually. These meetings will be held during a range of times to accommodate schedule needs. Needs and desires for those communities will be taken into account and TPA staff will reach out to interested stakeholder groups to gather input from specific interest groups.
- Regular Engagement Each phase of Vision 2050 will offer opportunities for input and feedback. This may include public meetings and workshops, surveys, an interactive comment map, Call for Projects and in-person meetings. Staff will share these opportunities via social media, the agency's biweekly newsletter, advisory committee and Board meetings, community presentations and other formats as needed. This will be broken out into three key phases:
  - Informational Phase Notify the public and stakeholders of the LRTP's purpose, timeline and major milestones as well as how they can get involved and stay informed throughout the process.
  - Decision-Making Phase Identify specific opportunities for the public and stakeholders to provide input at key decision-making points that will affect the development of the plan such as lists of projects, scenario planning and budget.
  - Review Phase Allow the public to review and provide input on a draft version of the plan.
- **Representative Input** –The target is to reach as many pockets of Palm Beach County as possible, with a special emphasis to traditionally underserved areas. Efforts will also be made to reach these populations through outreach events and virtual feedback.





• Statistically Significant Random Sample Survey —An independent, statistically significant random sample survey will be conducted to understand citizen priorities and preferences that may not directly communicate with the TPA frequently.

#### Informational Strategies

- Approachable Information Since the LRTP can be a complicated topic for the general public to easily grasp and understand, especially as it relates to the long-term impact, a conscious effort will be made to make the language and materials surrounding the LRTP as easy to digest as possible. This includes simple and consistent branding that is ADA compliant. Materials for the LRTP will include approachable information that avoids jargon and terms not commonly used by the general public. Simplified graphics will be shared when possible to show how and when input can be gathered.
- **Digital Tools** the TPA will use several digital tools to supplement in-person input. This includes the TPA's website, GIS mapping for review and input that will integrate the agency's Comment Map, a biweekly newsletter, social media, and online surveys.
- High-Impression Outreach Boosted social media posts that are focused within the geographic area of Palm Beach County will be used to reach more people and to gather more input. This will be used for the Comment Map, surveys and any other online tools as needed.

## **Engagement Methods**

TPA staff will hold up to 30 meetings with stakeholders including homeowner's associations, chambers of commerce, School District of Palm Beach County Board members, County Commissioners, and municipal government elected officials.

Staff will also host up to 20 in-person or virtual staff meetings with infrastructure owners and other major partners (FDOT, Palm Beach County Traffic and Planning Divisions, local municipalities, Palm Tran, South Florida Regional Transportation Authority, etc.) to give frequent updates and receive feedback.

Staff may exceed this number of meetings as input is gathered and staff work with stakeholders to develop the draft plan. This will also include workshops with the public, virtual webinars, inperson workshop opportunities for advisory committee members, tabling at community events, social media, etc.

Input will also be gathered online through the digital tools mentioned above.





## **Evaluation**

- April June 2024: Comments will be gathered through the TPA's Comment Map, survey responses and workshops.
- July August 2024: Comments will be gathered on the funding plan to determine how best to fund projects submitted through the Call for Projects. This will shape the draft and final plan.
- September October 2024: Comments will be collected for the draft plan before being adopted in December 2024. This will include at TPA advisory committee meetings, Board meetings, with stakeholders and general public review of the document on the TPA website.

## **Workshop and Public Input Opportunities**

The Palm Beach TPA hosted more than 30 workshops and presentations across Palm Beach County during the LRTP process to gather public input and feedback. Workshops were held inpersonal, virtually and in a hybrid format to allow for flexibility in attendance. All workshop materials were also posted to the TPA website following the event for public review and comment.

Those who attended LRTP Workshops included members of the general public, staff of transportation partners such as municipalities and transit partners, Governing Board members and special interest groups. Each workshop included boards to describe where the TPA was in the LRTP process, upcoming events and how to continue to stay involved.

TPA staff also presented to various groups throughout the LRTP process including Chambers of Commerce, the Palm Beach County League of Cities, neighborhood coalitions, business groups and more.

Printed resources were shared with participants to encourage them to stay involved and find more ways to interact online including the TPA's Comment Map, Vision 2050 Interactive Map and reviewing documents at <a href="mailto:PalmBeachTPA.org/LRTP">PalmBeachTPA.org/LRTP</a>.





## **Public Survey Responses**


The Palm Beach TPA shared an online survey from August 2023 to October 2024. The survey was shared in the following ways:

- PalmBeachTPA.org/LRTP
- Transportation Tuesday Bi-Weekly Newsletter
- Palm Beach TPA social media Facebook, Instagram, LinkedIn, X (formerly Twitter)
- TPA Governing Board and advisory committee meetings
- Public Workshops and Meetings (listed above)

The survey gathered 308 responses and informed the TPA on various topics including satisfaction with the current transportation system, priorities in transportation, and whether a designated funding source for transportation would be supported. Survey responses have been post processed for consistency.

To ensure anonymity of responses, respondents were not asked to provide individually identifiable information. However, residents shared their zip code at the conclusion of the survey to gather data on location within Palm Beach County.


#### Q1. Are you a resident of Palm Beach County?







## Q2. How satisfied are you with the quality of life in Palm Beach County?



# Q3. At this moment, which of the following would you consider to be the highest priority for county leaders?



# Q3. At this moment, which of the following would you consider to be the highest priority for county leaders?



Q4. What is your satisfaction with Palm Beach County's transportation system?\*



Q5. To what extent has your commute experience negatively affected your quality of life as well as ability to do things important to you?\*







# Q7. Of the following, which would you say is the second highest priority for transportation?



# Q7. How often do you travel to neighboring counties in the Tri-County Southeast Florida region?\*



# Q8. When traveling in the Tri-County Southeast Florida region, what is the highest priority for transportation planning?\*



# Q9. What do think about the current amount of tax money being spent to expand and improve public transit services and transportation infrastructure in Palm Beach County?\*







Q12. Close one lane to car traffic on some major local roads and designate it exclusively for public transit to reduce travel times\*



## Q13. Change zoning laws to allow more development near main roads to minimize commuting needs while making travel more efficient?\*





Q14. Have the local county government fund on-demand ride services throughout the county that provides riders with transportation to and from bus stops as well as train stations\*







## Public Survey Responses by Zip Code

The TPA's public survey gathered more than 300 responses from across Palm Beach County. Responses include feedback on a variety of topics, including main takeaways such as:

- The highest priority for county leaders was indicated as managing the county's growth and development (#1) and providing more affordable housing (#2)
- There was mixed satisfaction with the county's current transportation system, with more dissatisfaction than satisfaction
- The highest priority for transportation leaders were adding new transportation options, such as streetcars and lightrail, (#1) followed by improving transportation safety (#2)
- The highest priority for travel within the Tri-County Southeast Florida area was indicated as reducing roadway congestion
- More than half of respondents said too little tax money is being spend to expand and improve public transit services and transportation infrastructure in Palm Beach County (54%)
- More than half of respondents said it is a good idea to install more charging stations and other technology needed for utilizing electric cars (56%)
- More than half of respondents said they would favor replacing the current half penny infrastructure sales tax with a half penny sales tax that supports transportation (55%)

#### **Public Comment Map**


The Palm Beach TPA has hosted an online comment map at <u>PalmBeachTPA.org/comment-map</u> since 2020. This map was enhanced during the 2050 LRTP process to gather more comments related to the Plan, projects and future ideas. Users can submit a written comment of an observation, safety concern, suggestion or improvement and place a pin on the map of the location to be reviewed by TPA staff.

The comment map includes categories for topics including:





### Methods

July 31 – August 4, 2023

Data was gathered through a combination of secure SMS/text-to-web surveys and telephone interviews performed by specially-trained opinion research interviewers

Conducted in English and Spanish languages with 502 randomly-selected registered voters in Palm Beach County, Florida, using a combination of valid residential, VOIP and cellular telephone listings

+/- 4.37% overall estimated margin of error, with a confidence interval of 8.74% within which the results can vary

Data was stratified and results weighted so that the differences in vital characteristics, such as age, race, gender and geography, are represented in proportion to their percentages of the county's electorate

Due to rounding, not all results add up to 100%, and the data is presented in a different order than the questions were asked

Unless otherwise noted, only statisticallysignificant differences that were outside the confidence interval for the overall estimated margin of sampling error have been reported in this presentation of key findings








### **Mood of Voters**














Generally speaking, do you think that there is too much, about the right amount or too little tax money being spent to expand and improve public transit services and transportation infrastructure in Palm Beach County?









### **Key Findings Recap**

The mood of the electorate was a largely complacent one, which indicates that there were not any overarching issues or trenchant matters that could have tainted responses to the critical questions

At the time of the study, the need for housing eclipsed all other priorities, so planning discussions and initiatives that integrate the topic will resonate most loudly with voters

That said, the topic of commuting may warrant more examination with different measures to fully understand the shadow it casts over the topic of transportation planning

A narrow majority were satisfied with the current transportation system, but there were numerous results indicating that voters were open to – and, in some cases pining – for upgrades & improvements, especially those that will preserve the environment or facilitate the uses of emerging technology, such as electric cars and ondemand services

There was some support observed for improvements to public transit, but self-reports of ridership were quite modest, which suggests that, even those voters who support such ideas may not yet envision themselves as benefitting from them

Many were ambivalent about current road expenditures, which indicates that some public engagement on the topic may be needed or fruitful, in order to ensure an

informed electorate when a tax issue is placed before voters

The idea of special taxing districts may be too esoteric to be reliably gauged with a single question, but results suggested knee-jerk opposition to the idea

While there was very limited support for a full one cent sales tax to make upgrades and improvements, initial support for the half-cent sales tax was promising, but a decision to pursue it should not be undertaken without considering other factors...

Dear Valerie,

As you know, Palm Beach County Engineering and Public Works Department (EPW) has been working with the Palm Beach Transportation Planning Agency (TPA) staff on the long range transportation projects the County wants to be included in the Local Desires list of the 2050 Long-Range Transportation Plan (LRTP) and providing the needed information and technical data in support. This correspondence is intended to formally provide supporting data for the list of projects objected to by the City of Palm Beach Gardens (City), as outlined in the City Manager's letter to you dated October 30, 2024.

The City's letter voiced concerns about projects outside their municipal jurisdiction. Although appreciated, it is not within the scope of the City's responsibility to encroach on the policies and visions of the County and their neighboring municipal staff and leadership.

It is important for the City to keep in mind that road improvements are not only based on current traffic volume/demand. The road improvement projects in the LRTP are intended to accommodate future traffic demand based on the projected and anticipated future development and growth including comprehensive plan changes.

Most of the County roads listed in the Local Desires category either already have the needed Right of Way (ROW) or may require some ROW acquisition. In fact, some of the intersection improvement projects objected to by PBG are funded for construction in the current county 5-Year Program. Specifically, the design for the two intersection improvement projects at Donald Ross Rd/Military TRL and PGA Blvd/Central Blvd, which are listed below, are in the advanced stages. The City has not provided any detailed information indicating that these projects will have a detrimental impact on the City's roadway/mobility system or private properties or infrastructure as "assumed" in the City's objection letter.

It is imperative to keep in mind that this is a long-range transportation planning exercise, which includes projects intended to be built in the next 25-30 years. At this stage, the impacts of these projects on the surrounding private or public property cannot be fully ascertained. These potential impacts will be assessed when these projects are programmed for construction and actual engineering design process goes into



effect. At this stage, it is not prudent for the government leadership and technical staff to preempt, otherwise, essential transportation improvement projects merely based on passive/pessimistic and uninformed assumptions.

The City staff indicated the County may be violating its own comprehensive plan policies because it included some roads that were designated as Constrained Roadway At Lower Level of Service (CRALLS). The CRALLS designation is merely a policy option intended to promote/encourage/allow the urban in-fill and high density developments that would otherwise fail to meet the adopted Traffic Performance Standards (TPS). Furthermore, CRALLS designation of a roadway does not preclude it from future widening, if such an improvement is determined to be the best solution to mitigate traffic congestion and improve mobility for the betterment of the safety and wellbeing of the public. Since the adoption of the proportionate share legislation, the CRALLS has lost its appeal. Following are the responses from the EPW which were recently sent to the TPA staff:

The City of Palm Beach Gardens has raised concerns with the following projects. These projects exist in the Local Desires list but will not appear in the Cost Feasible model network or draft plan.

- Prosperity Farms Road from Lighthouse Drive to Burns Road and Burns Road to PGA Blvd (PAL0016, PAL0017) – in the Local Desires category.
  - The County maintains that five lanes are needed based on 2040 TPS volumes on the segment between Lighthouse Drive and Burns Rd. Most of the segment between Burns Rd and PGA Blvd is already five lanes.
- Donald Ross Road at Military Trail (PAL0133) additional Northbound left turn lane (resulting in three left turn lanes)
  - The project description is wrong. The improvement is to add a 3<sup>rd</sup> left turn lane on the west approach (eastbound to northbound left turn lane). This is an active Five Year Road Program (5YRP) project currently under design. This improvement is urgently needed based on the 2040 TPS traffic volumes/demand.
- PGA Blvd at Central Blvd (PAM0152) additional southbound right turn lane (resulting in two right turn lanes)
  - This is an active 5YRP project awaiting design completion. County maintains that two southbound right turn lanes are needed. Southbound right turn volumes are projected to be 1,000 vehicles per hour in 2040 based on the TPS database.



- Northlake Blvd from I-95 to Congress Ave (PAL0012) additional turn lanes north and east bound.
  - Intersection improvements may be required at Congress Ave, including additional 2<sup>nd</sup> northbound through and eastbound right turn lanes. FDOT may be including lane additions along Northlake Blvd as part of their I-95 interchange improvements which will also include a divergent diamond interchange.

City staff has reviewed the Palm Beach County Transportation Planning Agency ("TPA") 2050 Long-Range Transportation Plan ("2050 LRTP"). The LRTP serves as the official Long Range Transportation Plan for the County with emphasis on short-and long-term implementation, and also serves as the primary database for transportation modelling used by Palm Beach County for the purposes of projecting transportation impacts and necessary improvements.

Over the last several months, there has been a significant amount of communication and coordination between the City of Palm Beach Gardens ("City") staff and TPA staff regarding the proposed 2050 LRTP. Several vehicular, bicycle, pedestrian, and general mobility improvements were submitted by the City staff for inclusion in the 2050 LRTP. City staff also appreciates the proactive coordination process of providing projects submitted by various agencies within the City's jurisdictional limits for review. Many projects were interesting and noteworthy for staff. Several projects submitted within the City's boundaries are also concerning to City staff. This letter serves as a formal objection to projects within the City's jurisdictional limits that would have a detrimental impact on the City's roadway/mobility system as well as private properties and existing infrastructure. Specifically, City Staff has concerns with the following:

- PAL0012 Northlake Blvd (I95 to Congress) Lane Addition
- PAL0015, PAL0016, PAL0017 Prosperity Farms Road (Lighthouse Drive to Burns Road, Burns Road to PGA Blvd) – Lane Addition (Widen from 3L to 5L, intersection improvements)
- PAL0133 Intersection of Donald Ross Road and Military Trail additional NB left-turn lane (ultimately three left turn lanes)

There is a lack of detailed information with regard to the above-mentioned projects to know the specific actual impacts, however the segments listed for lane additions do not appear to have sufficient right-of-way available. Therefore, several types of impacts can be assumed (private property boundaries, Interstate 95 turn lanes and ramps, existing turn lanes, landscape buffers and existing mature landscaping, access driveways, parking areas, and existing bridges). Further, Northlake Boulevard and Prosperity Farms Road are both

listed under Policy 1.2-f in the Transportation Element of the Palm Beach County Comprehensive Plan with a Constrained Roadway at a Lower Level of Service (CRALLS) designation. This means that the Palm Beach County Board of County Commissioners (BOCC) has set as a policy that these roadways should not be widened, and consequently the submitted projects are inconsistent with the County Comprehensive Plan. Traffic counts on both of these roadway segments for 2023 indicate that the roadways are operating below the adopted daily and peak hour trip capacities.

We understand that TPA staff has not placed these projects in the Illustrative Funding List, and that they are in the Local Desires category, meaning they would not be eligible for federal funding through TPA programs and some discretionary grants. However the 2050 LRTP, known as "Vision 2050", sets the vision and tone for the County's long range transportation goals. The noted projects of concern are not in line with the principles and priorities that the City promotes with regard to safety and mobility. For these reasons, we request that these projects be removed from the 2050 Local Desires category.

In addition to the noted projects that are within the City's jurisdiction limits, City staff also noted several projects throughout the County that are concerning to the City for similar reasons as the impacts noted above (impacts to private properties, existing infrastructure, driveway, buffers and landscape, etc.). Specifically:

- PALOOO1 Center Street (Loxahatchee River Road to Alternate A1A) Lane Addition (widen 2L to 3L)
- PAL0006 / PAL0008 Donald Ross Road (Us-1 to A1A; Ellison Wilson Road to US-1) Lane Addition (widen 3L to 5L, widening to the median)
- PAL0029 Community Drive (Military Trail to Village Boulevard) Lane Addition (widen 2/3L to 5L)
- PAL0038 Palm Beach Lakes Boulevard (Village Boulevard to Australian Avenue)
   Lane Addition (add 4<sup>th</sup> NB/EB through lane)

We appreciate the ongoing communication and opportunity to comment prior to the upcoming adoption of the 2050 LRTP by the TPA Governing Board.

We are writing to express our strong desire that the widening or the 2 to 4 lane addition of Okeechobee Boulevard from 140th Avenue N to Crestwood Boulevard (PAL0063) and from Seminole Pratt Whitney Road to 140th Avenue N (PAL0062) remain unfunded as reflected on page 108 in the "Local Desires" segment of the *VISION 2050 Long Range Transportation Plan* put forth by the Palm Beach Transportation Planning Agency (TPA). We also appreciate and support TPA staff comments on the project worksheets relative to these two-lane addition projects reserving support until "demonstration of a project purpose and need beyond adding vehicular capacity. Specifically, the sponsor must address how the project would provide low-stress multimodal accommodations and leverage emerging technology that may yield similar mobility benefits."

Earlier this year, the Town Council similarly authorized a letter of objection about the proposed expansion of 40th Street North and 140th Street in the County's thoroughfare right-of-way identification map (TIM). As a rural community the Town has struggled over the years with the impact from increasing development surrounding our community in all directions. Perhaps the most significant of these impacts is the tremendous amount of traffic seeking alternate east and west as well as north and south short-cuts through our town roads which have not been designed for such elevated traffic patterns. The roads are intended to support local travel of our roughly 3,300 residents.

In fact, the purpose of Town's incorporation was to protect the rural character of our community from the encroachment of urban development patterns, including the adverse impacts of such cut-through traffic. In addition to working with the County over the years, particularly with respect to Okeechobee Boulevard, the Town adopted Ordinance 2021-04, restricting cross-jurisdictional access points that provide for ingress and egress between areas located within the Town and areas located outside the Town.

The adopted regulations have been incorporated into the Town's Unified Land Development Code as follows:

#### Sec. 100-040. – Private ingress/egress arrangements

(7) Private ingress/egress arrangements shall not provide ingress to and egress from areas within the Town from and to areas outside of the Town's corporate limits. Any ingress to and egress from areas within the Town from and to areas outside of the Town's corporate limits must be through a publicly dedicated street.
